Educational Information

The sources of drinking water, both tap water and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally- occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which shall provide the same protection for public health.

Contaminant Health Effects

LEAD

Copper is an essential nutrient, but some people who drink water containing copper in excess of the action level over a relatively short amount of time could experience gastrointestinal distress. Some people who drink water containing

COPPER experience gastrointestinal distress. Some people who drink water containing copper in excess of the action level over many years could suffer liver or kidney

damage. People with Wilsons Disease should consult their personal doctor.

Infants and children who drink water containing lead in excess of the action level could experience delays in their physical or mental development. Children could show slight deficits in attention span and learning abilities. Adults who drink this water over many years could develop kidney problems or high blood pressure.

Additional Health Information

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Fort Mccoy North Post is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Health Information

Radon is a radioactive gas that has no color, odor, or taste. Radon occurs naturally in waters across the United States and it can move through the ground and into homes via cracks and holes in the foundation. Radon can also be released directly from drinking water by agitation that occurs during showers, clothes and dish washing. Radon entering homes from drinking water is generally quite little compared to what enters through the foundation. Radon is a known human carcinogen. Breathing air contaminated with radon can increase the risk of lung cancer, particularly for persons who also smoke cigarettes.

Drinking water containing radon may also increase risk of stomach cancer, but the risk associated with drinking water is generally significantly less than the threat posed by radon in air. If you are concerned about your radon exposure, you should test the air in your home. If testing indicates a radon concentration of 4 picocuries per liter of air (pCi/l) or greater, you may benefit from a treatment system that would reduce radon levels in your home.
