SUBJECT: US Army Support Activity, Fort Dix Command Policy Memorandum #2 - Uniform Wear

1. This policy memorandum supersedes, US Army Support Activity, Fort Dix Command Policy Memorandum #2 - Uniform Wear, dated 14 August 2015.

2. **APPLICABILITY:** This policy applies to all Soldiers assigned or attached to US Army Support Activity (USASA), Fort Dix and Devens Reserve Forces Training Area. In addition, all Soldiers assigned to units conducting training or processing through USASA, Fort Dix, and Devens Reserve Forces Training Area will adhere to this policy.

3. REFERENCES:

a. AR 670-1, Wear and Appearance of Army Uniforms and Insignia, dated 30 March 2014.

b. DA Pam 670-1, Guide to the Wear and Appearance of Army Uniforms and Insignia, dated 2 December 2014.

c. Army Directive 2016-20

4. Wear of Military Clothing On and Off-Post Areas:

a. Army Combat Uniforms (ACUs) and Operational Camouflage Pattern (OCP) are authorized for wear on and off post.

b. ACUs are not authorized for wear in establishments that primarily sell alcohol.

5. Wear of the Patrol Cap and other Headgear.

a. The patrol cap is the basic headgear for utility uniforms in the garrison.

b. Soldiers will not wear the black beret in the field, in training environments, or on deployments; however, Soldiers may have it packed with them. Additionally, unit

Commanders may authorize the wear of the black beret for special occasions such as;
change of command ceremonies and award ceremonies.

c. The foliage green or black fleece cap may be worn with the ACU in the garrison while conducting extended duty outdoors (i.e. work detail, motor pool operations, etc), once the temperature, including wind chill factor, is 32 degrees Fahrenheit or below.

d. The drill sergeant hat is worn with the service and utility uniforms only by male or female drill sergeants assigned to valid drill sergeant positions.

6. Improved Physical Fitness Uniform (IPFU): The IPFU may be worn on or off duty when engaged in physical training both on and off the military installation. This uniform may be worn in transit between the individual's quarters and place of duty. Soldiers may wear all or part of the IPFU off the military installation. The shirt will be worn tucked inside the trunks or pants. Black or gray spandex biking shorts with no "logo" may be worn under the Army physical training shorts. Service members may wear a clean physical fitness uniform from their appropriate service in the dining facility, as long as it is not badly soiled, dirty or wet. The foliage green or black fleece cap may be worn with the IPFU. The wear out date for both the foliage green fleece and IPFU is, 30 September 2017.

7. Army Physical Fitness Uniform (APFU): The APFU may be worn on or off duty when engaged in physical training both on and off the military installation. This uniform may be worn in transit between the individual's quarters and place of duty. Soldiers may wear all or part of the APFU off the military installation. The shirt will be worn tucked inside the trunks or pants. Black or gray spandex biking shorts with no "logo" may be worn under the Army PT shorts. Service members may wear a clean physical fitness uniform from their appropriate service in the dining facility, as long as it is not badly soiled, dirty or wet. The black fleece cap may be worn with the APFU. The foliage green fleece is not authorized with the APFU. The IPFU and APFU may not be worn as a mixed uniform. The mandatory possession date for the APFU is, 1 October 2017.

8. Personnel are authorized to wear conservative and discreet headphones (Ear pads cannot be more than 1.5 inches in diameter at the widest point) during individual PT in a designated area only. Soldiers may not wear their headphones beyond the permitted area in any manner, including around the neck or attached to the uniform. Soldiers may wear electronic devices, such as music players or cell phones in accordance with AR 670-1.
