### Federal Tuition Assistance (FTA) Status (Section 3)

### Statement of Understanding (Section 4)

The NGSG is subject to availability of funds. Grant amounts are based on 30 credit hours of enrollment per academic year, 15 credit hours maximum per semester, UP TO 100% of certain tuition costs and regularly assessed fees. The student must meet the Satisfactory Academic Progress (SAP) standards (minimum GPA & other criteria) as defined by the attended institution. Other eligibility criteria and specific information about the NGSG can be found on the NGSG Information sheet. Failure to meet the eligibility criteria may result in forfeiture of current and/or future use of NGSG funds. Email is the primary means of communication between the INARNG State Education Office and NGSG applicants. Failure to monitor and respond appropriately and timely to guidance sent via email may result in missing out on key information and loss of your potential school funding. **REMEMBER!!!** Deadline is **15** days prior to the start of class! Late applications may be accepted on a case by case basis.
