SUBJECT: Supplemental Guidance for Proper Use of Energy Savings Performance Contract (ESPC) Authorities

- 2. An ESPC is a contract that provides for the design, acquisition, installation, testing, and, where appropriate, operation, maintenance, and repair, of an identified energy or water conservation measure or series of measures at one or more locations. The term of an ESPC may be for a period that does not exceed 25 years.
- 3. The FY11 National Defense Authorization Act provided clarification that ESPCs shall not be used for the construction of new buildings or facilities.
- 4. If construction of a building or facility is ancillary to and necessary for achieving the purpose of, the energy savings performance (for example, constructing a covered facility to house HVAC equipment for protection from inclement weather), the ESPC vehicle may be considered.
