EDMO INFORMATION UPDATES

Change in Serial Number Profile (SNP) for all items with Federal Supply Class (FSC) 76XX and 84XX

Going forward, the FSCs 76XX and 84XX will no longer have a Serial Number Profile (SNP). If you had an error reports referencing the requirement for serial numbers on any of the below list of FSCs, please disregard as they are changing to no serial number required.

7610, 7630, 7640, 7641, 7642, 7643, 7644, 7650, 7660, 7670, 7690, 8405, 8410, 8415, 8420, 8425, 8430, 8435, 8440, 8445, 8450, 8455, 8460, 8465, 8470, and 8475

Change in Serial Number Profile for Protective Masks

It has been determined by Department of the Army (DA) G4 that all Protective Masks (M40 series), with the exception of M50/M51 series, will no longer have a SNP. This affects a substantial amount of UICs that previously had error reports stating these items had a SNP, but no serial numbers were recorded. If you have error reports against the older protective masks stating they had a SNP but no serial numbers were recorded, those errors should drop from your listing within the next month (as the Material Master Catalog listings are processed against your UIC records). If you had previously created serial numbers for any masks (other than M50/M51), ensure you delete those serial numbers.

Disposition Instructions for Legacy STAMIS Components

DA G4 has produced documentation for the accountability of new "Z" Line Item Numbers (LIN) in GCSS-Army after conversion. Also, disposition instructions have been published for the legacy STAMIS systems currently in use (PBUSE, SAMS-E, and SARSS). This information is found in the three attached documents below.

New D-270 Pre-Recorded Kick-Off Briefing established by PM, GCSS-Army

PdM GCSS-Army has changed the D-240 Kickoff briefing to a recorded D-270 briefing in GTRAC (See GTRAC Smart Book link below for instructions on how to register). Organizations have approximately 30 days to view the D-270 kickoff brief prior to their scheduled D-240 Pulse Check. The D-270 kickoff brief can be found under the Wave 2 NET section under "As Required Courses within GTRAC". (URL: www.gcass.army.mil/GTRAC). This will be the avenue the PdM utilizes to confirm which organizations have viewed the D-270 kick-off brief within each Fielding Group and by Fielding Element. This training should be viewed by all who will participate in any portion of the GCSS-Army fielding.

Document for comparing the Data Staging Utility (DSU) Conversion Readiness Scorecard (CRS) Errors to EDMO Data Error Reports

Once an Organization enters D-240, the lead for GCSS-Army Wave 2 data cleansing effort transitions to the PdM GCSS-Army. They will produce a monthly DSU CRS for each Fielding Element and this report should be the organization's focus on cleansing Data Conversion Errors. Organizations will be able to download their CRS from the GCSS-Army Launch Pad (directions are below, "Retrieve Scorecard") in the EDMO Portal. The scorecard contains error reports equivalent to the EDMO "Data Conversion" errors on the EDMO Portal. The terminology/wording on the DSU Scorecard may differ from terminology/wording on EDMO Error Reports. To assist with data cleansing efforts, use the document posted below to compare EDMO Data Conversion errors to their equivalent DSU CRS errors. Submitting SAMS-E Dump (.dmp) Files

Did you notice duplicate errors on your last DSU CRS? If so, this is a result of uploading a SAMS-E .dmp file more than once. PdM has omitted the "delete uploaded file" function from the GCSS-Army Backup Submission Module so users can no longer delete a file they uploaded. So if you upload a file and decide later that it was not the one you want processed for whatever reason, and want to upload another one, contact one of the DSU CRS POCs above to have the unwanted file deleted. For organizations outside the D-240 window, contact EDMO to have the file deleted. If EDMO processes a duplicate file, it doesn't duplicate the errors but, the second file processed will overwrite the first one. So if the unwanted file is processed after the correct one, then the correct file is overwritten.
