U.S. ARMY GARRISON WEST POINT POLICY #4

SUBJECT: Alternate Side Parking Policy in Designated Housing Areas During Snow Events

1. PURPOSE. To establish a policy for moving privately owned vehicles of residents of West Point housing to facilitate the clearing of roads for emergency vehicles and residential traffic during and after snow events.

2. APPLICABILITY. This policy applies to residents of the New Brick, Grey Ghost, Stony Lonsome I and Stony Lonsome II Housing areas as designated by appropriate signage (Encl).

3. POLICY. Residents of designated areas will be required to move privately owned vehicles that are parked on residential streets to facilitate snow removal operations.

4. PROCEDURES.

a. Balfour Beatty Communities (BBC) has installed signs that identify one side of the road as Side A and the other as Side B. Prior to or during a major snow storm, residents will be notified by BBC of the following:

(1) That the Alternate Side Parking Plan is either in effect or suspended.

(2) If in effect, to park on Side A or in prescribed driveways and, on order, the next day relocate privately owned vehicles to Side B.

b. BBC will notify residents by e-mail and phone concerning plan activation and cessation. In general, the plan will be activated when BBC determines that snow removal operations in the designated housing areas are expected in the next 48 hours.

c. Upon notification, residents should move their privately owned vehicles to off-street parking if possible.

d. Initial activation of the plan will always start with parking on the A side of the street. Vehicles that cannot be moved to off-street parking should be parked on the A side of the street within six hours of notification.

e. Vehicles located on Side A must be moved to Side B after BBC plows make their first series of passes of the neighborhood and before 1200.

f. The relocation of vehicles from one side to the other will continue daily until BBC notifies residents that the plan is no longer in effect.

5. RESPONSIBILITIES.

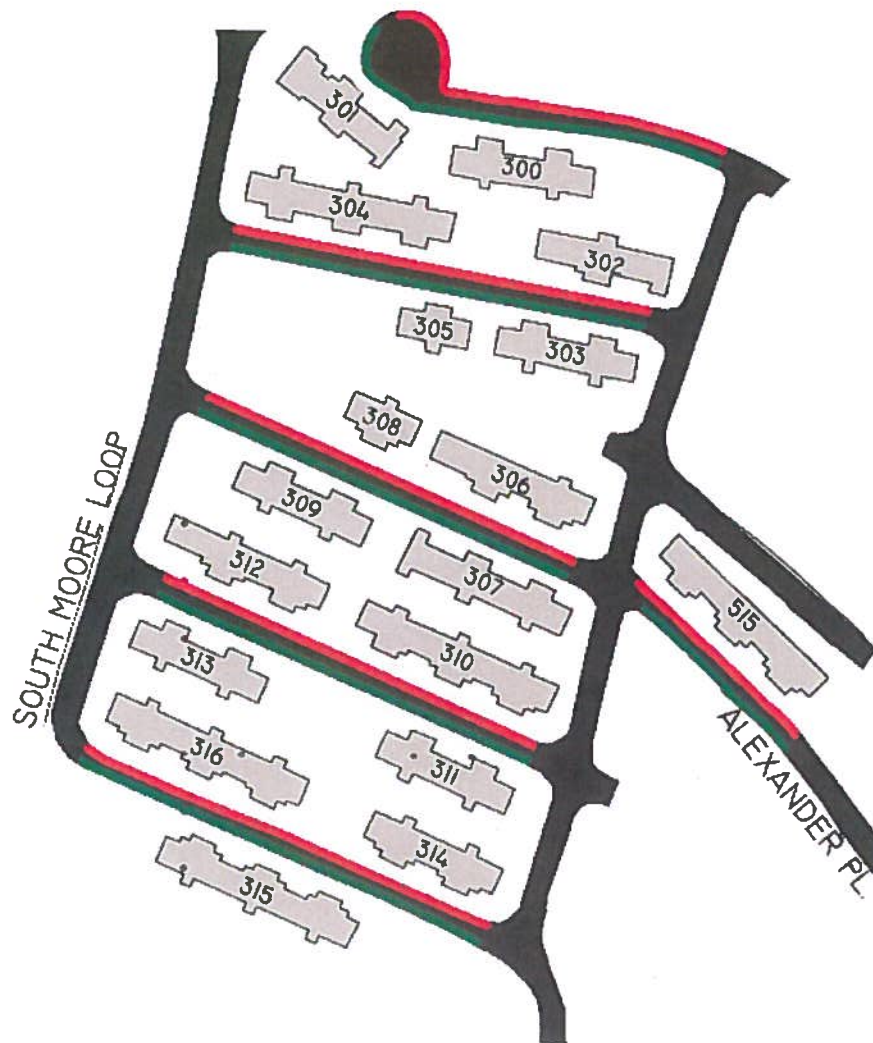
a. BBC will notify residents when the policy is in effect.

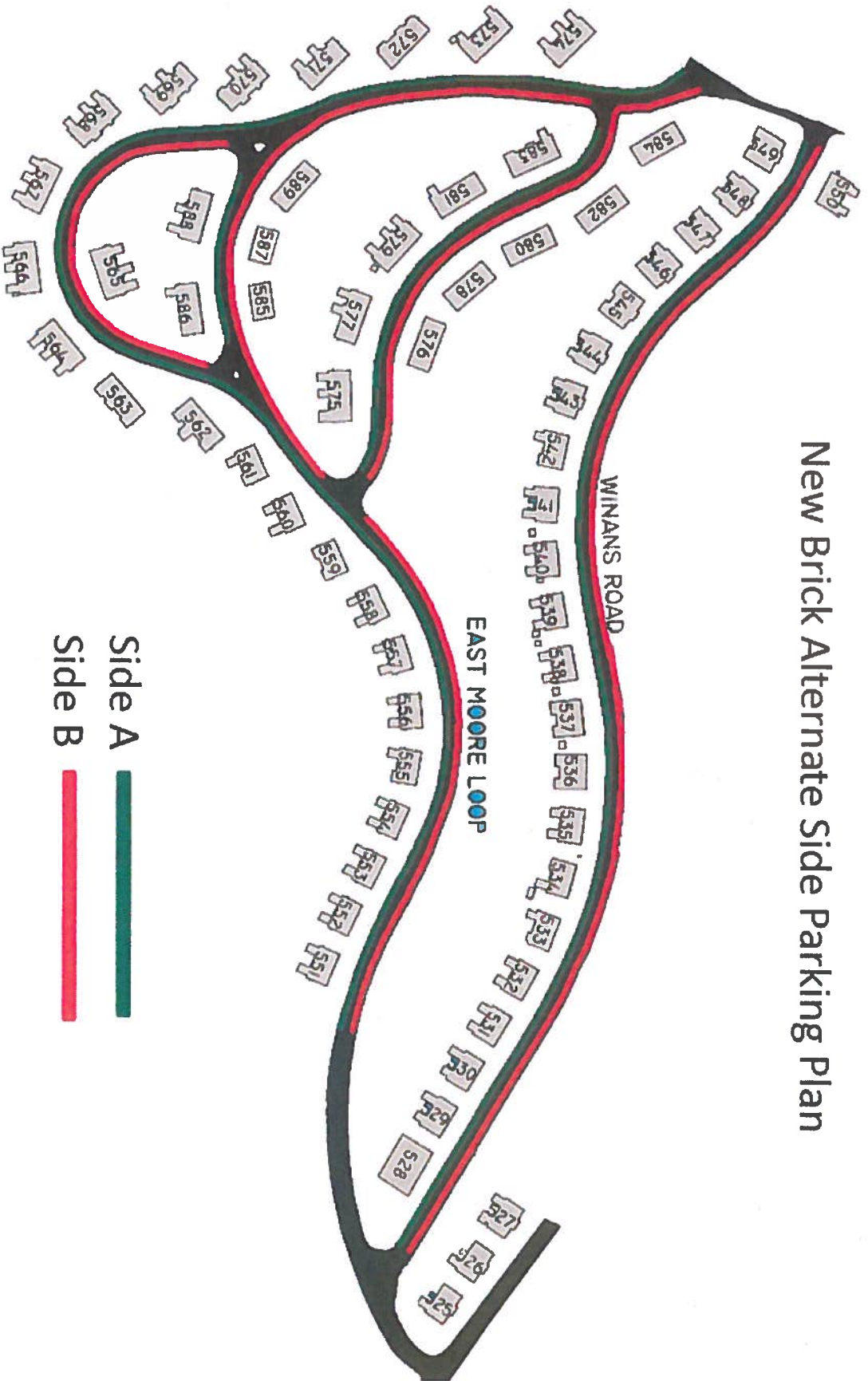

Grey Ghost Alternate Side Parking Plan



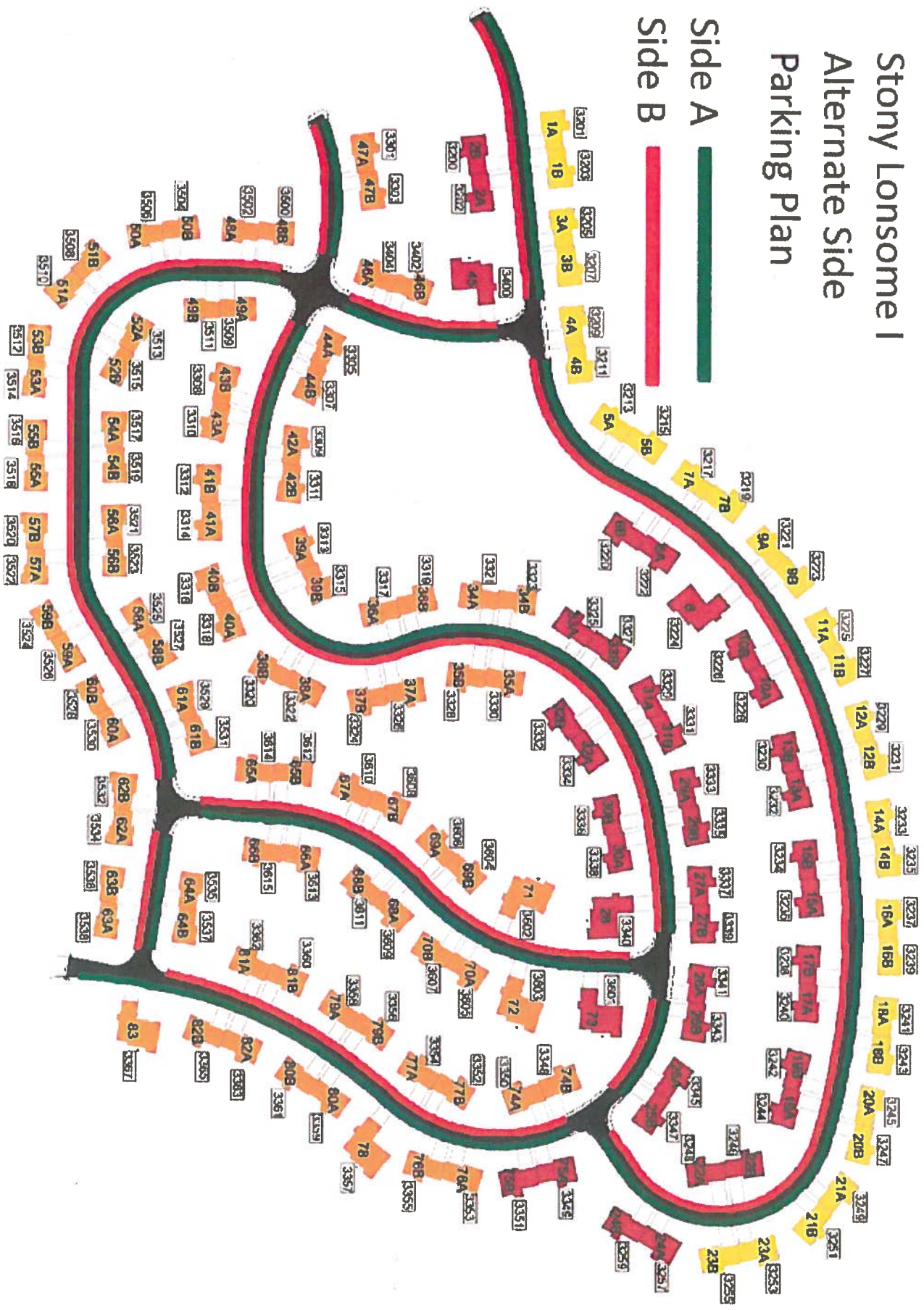
