U.S. Army Garrison West Point Policy # 27

SUBJECT: Operating Policy for the Army Sustainment Command's (ASC), Logistics Readiness Center West Point (LRC WP), Dining Facility (DFAC) at the U.S. Military Academy Preparatory School (USMAPS)

1. REFERENCES:

- a. AR 30-22, The Army Food Program, dated 24 July 2012.
- b. DA Pam 30-22, Operating Procedures for the Army Food Program, dated 6 February 2007.

2. PURPOSE: To establish general guidance and policy for operation and use of the DFAC located in the USMAPS facility, Building 950, Reynolds Road, West Point, NY.

3. GENERAL: USMAPS is the primary supported activity, with an approximately 250 person active duty enlisted student population on Subsistence in Kind (SIK) status – single Soldiers residing in the USMAPS barracks who are meal card holders not receiving Basic Allowance for Subsistence (BAS). Other U.S. Military Academy and USAG WP supported units, activities and individuals will also be provided food service support on a joint use, consolidated basis. The DFAC will be operated under the provision of the standard Army Food Program.

4. COMMAND AND CONTROL: The DFAC is under command of the CG, ASC through the Director, LRC West Point. As the principal supported activity, the Commandant, USMAPS will be afforded first priority and consideration for USMAPS required food service in support of the training and development program for assigned Cadet Candidates. The DFAC will be operated as a Government Owned Contractor Operated (GOCO) service under supervision and technical control of the Logistics Readiness Center (LRC). An ASC-WP LRC Contracting Officer's Representative (COR) will serve as the sole individual legally empowered to provide guidance and coordinate food service requirements from USMAPS and/or other activities, in coordination with the Contractor's Project Manager and the Contracting Officer.

5. FUNDING: Operating costs are principally underwritten through normal LRC WP Base Operations (BASOPS) funding. Food costs for SIK/Meal Card Holders will be expensed and managed in accordance with (IAW) the annually published DOD

established Basic Daily Food Allowance (BDFA). Meal prices for other patrons authorized use of the facility (non-SIK/non-Meal card Holders) will be IAW the annually

published DOD Food Service Charges for Appropriated Fund Dining Facilities. Food Service support desired by any unit/activity, including USMAPS, which may exceed Department of Army established Common Levels of Service and/or ASC-WP LRC funding will be requested and approved through the appointed COR in advance of the desired service and may be subject to reimbursement by the requesting activity.

Meal hours will be adjusted as necessary to meet mission requirements of USMAPS and others, such as football weekends, United States Corps of Cadets and USMAPS Graduations, Reception Days, and other special events. Patronage will generally be restricted to USMAPS Cadet Candidates, USCC Cadet Cadre, USMAPS Staff and those directly involved in executing Cadet Candidate Basic Training from start to finish each summer.

7. AUTHORIZED PATRONS: Under the provisions of Para 3-34, AR 30-22, I hereby authorize USMAPS Cadet Candidates and Staff, U.S. Corps of Cadets members and Staff, USMA/West Point Staff and Faculty, Tenants, DOD Civilians, Contractors working on-post and bona fide guests as authorized patrons. The Commandant, USMAPS; Commandant of Cadets; USMA Dean; and Garrison Commander are authorized to invite additional guests as required to meet specific mission demands.
