SUBJECT: Collateral Duty Safety Officer (CDSO) Appointment

- 2. Effective <u>date</u> the addressee is assigned the duties of Collateral Duty Safety Officer, for the <u>organization</u> (example: Fitness Center, Recreation Division, Directorate of Family, Morale, Welfare, and Recreation), Building 638, United States Army Garrison, West Point, New York.
- 3. Purpose. To assign the designated employee the duties of the CDSO for the Fitness Center located in Building 638.
- 4. Period. Until rescinded.
- 5. Special Instructions.
- a. As the CDSO you will report directly to the Chief of the Recreation Division on all safety related matters.
 - b. You may coordinate your CDSO related activities with the Garrison Safety Office.
- c. You are authorized the use of official time for participating in safety and occupational health activities, including application of risk management, walk-around

inspections, and other safety functions authorized by the referenced publications in support of the Fitness Center's mission.

- d. You are required to complete the Army Safety Center on-line CDSO course within 30 days of this appointment. Within the next six months you are also required to attend the 10 Hour OSHA Course provided by the Garrison Safety Office and any additional training required to perform your CDSO duties. The Garrison Safety Office will assist you and your appointing official with development of your Individual Development Plan to assure that you are adequately trained and competent to perform you CDSO duties. This training will include applicable safety occupational health requirements; evaluation and abatement of safety and occupational health hazards; procedures for reporting and investigating allegations of reprisals; the recognition of potential hazardous conditions and environments; identification and use of Army, command, and local SOH standards; and other appropriate rules and regulations that will assist you in performing your CDSO duties.
