5. Summary of Proceedings

a. Welcome Remarks

Stephen Glasscock, Committee Designated Federal Official, welcomed committee members and conveyed Ken Leonard's apology that he could not attend the meeting due to an ITS JPO senior leadership offsite training activity.

- b. Opening Remarks
 - (1) Chairperson Wilkerson welcomed committee members, thanking them for taking time from their professional lives to participate in this important committee. She also thanked Stephen Glasscock for his outstanding administrative and logistical support to the committee.
 - (2) Chairperson Wilkerson stated that the main purpose of the meeting was to review subcommittee recommendations initial drafts, with the goal of submitting a formal interim advice memorandum to the Secretary in September 2015 that would be followed by a final advice memorandum in mid-2016. She made the following observations based on her review of the subcommittee initial drafts:
 - (a) The committee should establish a report template to facilitate preparation of the final report.
 - (b) Some of the reports had significantly more information than others, some had charts, and some had more introductory and background information than the others; so the committee will need to reach consensus on information that will be included in the recommendations, information can be combined, and information that can be omitted.
 - (c) Some reports included suggestions, but no formal recommendations. The final report to the Secretary must include specific recommendations.

c. Open Discussion of Subcommittee Draft Recommendations

The Funding, Public Transportation, Data, and Shared Used Mobility subcommittee chairpersons briefed the committee-of-the whole on their draft recommendations and facilitated group discussions. There was consensus to conduct the Scenario Planning subcommittee discussion following the subcommittee meetings.

d. Subcommittee Meetings

The subcommittees met to consider feedback received during the preceding open discussion of their draft recommendations. The subcommittee meetings were conducted in two rounds – first the Funding and Data subcommittees, followed by the Public Transportation and Shared Mobility subcommittees.

e. ITS JPO Update

During the lunch break, Mr. Walt Fehr, ITS JPO Systems Engineering Program Manager, presented an ITS JPO update on ITS systems security, current efforts to enhance uniformity among impending Connected Vehicle Pilot deployments, and plans to provide the Pilot deployment sites unified, easy-to-use support services to enhance program success.

f. Scenario Planning Group Discussion

Following a wide-ranging discussion on scenario planning, the committee reached consensus that this topic required further development; so it would not be included in the committee's interim advice to the Secretary in September, but instead would be discussed at future committee meetings for possible inclusion in the committee's final advice memorandum in 2016.

- g. Discussions of ITS Technologies in Government Fleet Vehicles and Workforce Development
 - (1) In response to Mr. Berg's request, Chairperson Wilkerson opened the floor to discussion of potential advice to the Secretary on whether future government solicitations for the purchase of fleet vehicles shoud include the requirement that the vehicles be able to accommodate future government mandates for in-vehicle ITS technologies. Mr. McCormick agreed to drafting a recommendation on this topic.
 - (2) In response to Chairperson Wilkerson's request for recommendations of additional topics for discussion, Mr. Albert recommended workforce development, which had been discussed during the Public Transportation subcommittee open discussion. Mr. Albert agreed to draft a recommendation on this topic.
- h. Subcommittee Updates to Committee

The Data, Funding, Public Transportation, and Shared Use Mobility chairpersons presented brief updates to the committee-of-the whole based on results of their subcommittee meetings.

i. Review Action Items
