### 3 Welcome

- 4 MR. GLASSCOCK: All right, Sheryl, if you are ready, I will
- 5 go ahead and open the meeting. Welcome, everyone. We hope it
- 6 is a good productive hour, quick call.
- 7 A few housekeeping items. Please remember, if you can, to
- 8 identify yourself for the court reporter who is recording the
- 9 entire meeting.
- 10 And before I hand it over to Sheryl, I am going to let Ken
- 11 introduce our acting managing director.
- 12 MR. LEONARD: Hi, this is Ken Leonard. And I just wanted
- 13 to tell you that joining me today, actually, joining us in the
- 14 ITS JPO for the next 90 days is Egan Smith. And I will let Egan
- 15 introduce himself.
- MR. SMITH: Hi, I am Egan Smith. I am originally from the
- 17 Office of Planning. I have been involved in performance-based
- 18 planning and programming, planning for operations, ITS-related
- 19 and connected vehicles for quite some time now.
- So, it is great to be here with Ken and the group on this
- 21 rotational assignment in the JPO.
- MR. LEONARD: So, we are really happy to have Egan here.

- 1 Many of you met Jeff Onizuk, who was our acting managing
- 2 director. He was on a detail previously. He got a permanent
- 3 assignment actually outside the DOT in a legislative affairs
- 4 position, which, as many of you may recall, was his background.
- 5 So, he has happily moved to the USGS, where he is doing work
- 6 he is very familiar with.
- 7 I do want to tell everybody on the telecom to spread the
- 8 word. We are going to be tweeting this out, putting it out every
- 9 way we can but we are now about to -- we have actually released
- 10 today to USAJOBS the announcement to permanently fill this
- 11 position, the managing director position. So that is, right
- 12 now, open to the 22nd. We are trying to getting it extended
- 13 over the weekend of the 25th and we think we will be able to
- 14 do that.
- But in the meantime, there is about ten days to bid that
- 16 position on USAJOBS. So, let your colleagues know, let your
- 17 friends know, folks who you think are interested in working in
- 18 the ITS JPO in the managing director position.
- 19 We are also going to be advertising shortly a backfill
- 20 position that we are having someone start a detail on Monday
- 21 to backfill behind Kate Hartman's position.
- So, it takes us a while to process these backfills because

- 1 we have to go through a waiver process but we are bringing in
- 2 some permanent replacements for the folks who have moved on to
- 3 promotions elsewhere. So, I just want to -- another little JPO
- 4 housekeeping item.
- 5 All right, so Sheryl, I will turn it over to you.

### 6 Roll Call

- 7 VICE CHAIR WILKERSON: Okay. First of all, Steve, I know
- 8 we had one request to resubmit the agenda, if it is possible,
- 9 if you are at your computer, if you are able to recirculate that
- 10 or send that out again, that would be great.
- 11 MR. GLASSCOCK: Okay.
- 12 VICE CHAIR WILKERSON: And then second, for those of you
- 13 who are on a mobile or have your phones, we are getting some
- 14 noise. If you would mute your phone, unless you are speaking.
- And then before we start, there were a few other people who
- 16 joined. I don't have Scott Belcher, Roger Berg, Joe McKinney.
- 17 I don't have Joe Calabrese, John Capp, Raj --
- 18 MEMBER CALABRESE: Joe is here.
- 19 VICE CHAIR WILKERSON: I'm sorry?
- 20 MEMBER CALABRESE: Joe Calabrese is on. Thank you.
- 21 VICE CHAIR WILKERSON: Oh, great. John Capp, Raj --
- 22 MEMBER CAPP: John Capp here.

- 1 VICE CHAIR WILKERSON: Okay. Is Raj on or Bob Denaro?
- 2 MEMBER MCKINNEY: Hey. Joe Mc Kinney is on.
- 3 VICE CHAIR WILKERSON: Okay, great.
- 4 MEMBER JOHNSON: Debra Johnson is present.
- 5 VICE CHAIR WILKERSON: Oh, great. Thank you. And that
- 6 was Debra and who was the one before Debra? Joe.
- 7 MEMBER MCKINNEY: Joe McKinney, yes.
- 8 VICE CHAIR WILKERSON: Okay, great.
- 9 So, this meeting has been called to order. I have been
- 10 asked to chair today's call. We will try our best to keep it
- 11 brief.

# 12 Meeting Purpose

- 13 The purpose of the meeting is to primarily go over the
- 14 subcommittee updates that we discussed during our February 4
- 15 through 5 meeting in Crystal City. The goal of that two-day
- 16 meeting, as you recall, was to identify the committee's topics
- 17 of focus for advice to the Secretary and to select committee
- 18 members' preferences for service on various subcommittees.
- During that discussion, for those of you who were unable
- 20 to participate, we had a discussion by Tim Klein, Acting
- 21 Director of Technology Policy and Outreach on the report, Beyond
- 22 Traffic: USDOT's 30-Year Framework for the Future.

- 1 We also had Daniel Morgan talk about trends in open data;
- 2 Jack Hall, who discussed several of the Contra Costa
- 3 Transportation Authority's multimodal projects; Brian Cronin,
- 4 who gave a presentation on Operations and the Connected Vehicle
- 5 at FHWA; Walt Fehr, who gave an update on Connected Intelligent
- 6 Transportation Systems -- a Complete Overview; Nat Beuse from
- 7 NHTSA and then we also had some comments from Greg Winfree.
- 8 Following the discussion on major topics for the
- 9 committee's advice, the committee reached consensus on six key
- 10 topics. And at the meeting, the committee summarized the
- 11 various areas that the subcommittee would like to investigate
- 12 further. And we initiated a chart, where we asked the various
- 13 members in attendance to select which subcommittees they would
- 14 like to serve on.
- 15 As of today, we have a Data Committee, which is chaired by
- 16 Bob Denaro; Part of being a Public-Private Partnership, chaired
- 17 by Ginger; the Scenario Planning chaired by Scott McCormick;
- 18 Public Transportation Chair Joe Calabrese; and then we have the
- 19 Shared Use Chair, by Susan Shaheen.
- We have agreed that we would not, at this time, look at
- 21 freight intermodal. So, there was no selected subcommittee.
- 22 I believe, at that time, the only people who had not been

- 1 assigned a committee were Steve Albert and Peter Kissinger.
- 2 So, before we go to the Data Subcommittee summary, does Steve
- 3 or Peter, have you determined which subcommittees you would like
- 4 to serve on?
- 5 MEMBER ALBERT: Steve has, I think, forwarded that to Steve
- 6 Glasscock and also provided comments already to Ginger.
- 7 VICE CHAIR WILKERSON: Oh, fantastic. Okay.
- 8 MEMBER KISSINGER: This is Peter. I have been working
- 9 with the Data Committee.
- 10 VICE CHAIR WILKERSON: You're on data. Was there any
- 11 other committee?
- 12 MEMBER KISSINGER: I think I did that. I honestly don't
- 13 remember which one.
- 14 VICE CHAIR WILKERSON: Okay. And then Steve, you are on
- 15 Public-Private and what was the other?
- 16 MEMBER ALBERT: I don't think I picked another one.
- 17 VICE CHAIR WILKERSON: Okay. All right. So, I had also
- 18 sent a note to Bob. He requested to be put on the Data
- 19 Committee. So, I think that is it. And I don't have any other
- 20 comments, if anyone has any comments about what I just said or
- 21 questions for you to chime in. Otherwise, we will just start
- 22 in on the subcommittee updates.

- 1 MEMBER MCCORMICK: This is Scott McCormick again. I just
- 2 had a quick question. Was Steve Kenner going to be able to join
- 3 or no?
- 4 VICE CHAIR WILKERSON: I have -- hold on one -- no. Right
- 5 now we don't have an update for him. That is why I am chairing
- 6 the meeting.
- 7 MEMBER MCCORMICK: Okay.

# 8 Data Subcommittee Update

- 9 VICE CHAIR WILKERSON: Okay, so if there are no further
- 10 questions, why don't we start with Bob?
- 11 MEMBER DENARO: Hi, Sheryl.
- 12 VICE CHAIR WILKERSON: Hi.
- MEMBER DENARO: And hi, everyone. Yes, so we had a couple
- 14 of phone calls and threw out a bunch of ideas and deliberated
- 15 a bunch of things. And I sent around last night, late, for those
- 16 of you who saw it, the current list that we came up with, which
- 17 was four recommendations.
- In addition to that, we have some comments subsequent to
- 19 that meeting from both Peter Kissinger and from you, Sheryl.
- 20 So, we would like to capture that information as well and, going
- 21 forward, include that in our draft.
- But at this point, I think what we are trying to do, if I

- 1 am not mistaken, Sheryl, is we want to bring the draft
- 2 recommendations back to the entire committee to discuss which
- 3 ones may have merit to go forward as formal recommendations from
- 4 the entire committee. Is that correct?
- 5 VICE CHAIR WILKERSON: Yes. And as part of our next steps,
- 6 we will discuss the fact that we agreed, the subcommittee has
- 7 agreed to prepare the initial draft of their reports by July
- 8 17th. So, we will combine all of those and combine them into
- 9 an advice memorandum.
- 10 MEMBER DENARO: Okay. So, just so I am clear, we are going
- 11 to a draft of recommendations by July 17 but are we going to
- 12 then co-load down in the general committee prior to that going
- 13 into a --
- 14 VICE CHAIR WILKERSON: Yes, that is my understanding,
- 15 unless Steve has any other comments, but that is my
- 16 understanding. And if we get them by July, we should certainly
- 17 have time in our face-to-face meeting, which is scheduled for
- 18 August.
- 19 MR. GLASSCOCK: Right. So, I haven't had a chance to work
- 20 with Sheryl yet. This is Stephen, on the agenda for the August
- 21 meeting. But it was our thought or my thought that with the
- 22 submissions in July, then you could take those and talk and

- 1 discuss and do what you want at the August 15th in-person
- 2 meeting.
- 3 VICE CHAIR WILKERSON: August 13th.
- 4 MR. GLASSCOCK: August 13th. I'm sorry, August 13th.
- 5 VICE CHAIR WILKERSON: That's okay.
- 6 MEMBER DENARO: Okay.
- 7 VICE CHAIR WILKERSON: Is that okay, Bob?
- 8 MEMBER DENARO: Yes, it is. It is clarifying for me. For
- 9 some reason, I missed the fact that when the meeting was going
- 10 to be. So, it is August 13th.
- 11 VICE CHAIR WILKERSON: Yes.
- 12 Okay, so does anyone have questions?
- 13 MEMBER MCCORMICK: Yes.
- 14 VICE CHAIR WILKERSON: Yes.
- 15 MEMBER MCCORMICK: I didn't realize we had picked a date
- 16 for it either. So, that is good to know. Oh, wait. No, I
- 17 apologize. I do have it on my calendar. I was looking on my
- 18 calendar and I couldn't find it. So, I'll be quiet.
- 19 VICE CHAIR WILKERSON: Not to worry. Does anyone else
- 20 have any questions for Bob or the materials that he sent out?
- 21 If so, feel free to join the subcommittee and/or submit comments
- 22 to him by email.

- 1 MEMBER KISSINGER: Bob, this is Peter. Did you want me to
- 2 say anything or just wait to work with the subcommittee?
- 3 MEMBER DENARO: Well, I guess, Peter, maybe I will say
- 4 both, if we have time here. Why don't you go ahead and say the
- 5 thoughts you had, just so everyone can hear that. But it looks
- 6 like we now have until July 17, which I didn't understand, to
- 7 pull together a draft. So, I would like to get your input and
- 8 construct new recommendations, based on that.
- 9 So, why you don't say briefly, since no one else has heard
- 10 it, what you have in mind.
- 11 MEMBER KISSINGER: I mean I had two suggestions. The one
- 12 was, I mean given the benefits that are forecast for connected
- 13 vehicles, I had asked the question, really, will we have
- 14 sufficient data to be able to conduct evaluation of the
- 15 effectiveness of the connected vehicle, when they are, in fact
- 16 on the road.
- 17 The second one was perhaps a little broader. If I look at
- 18 connected vehicle in sort of the broadest possible way to define
- 19 it, can some of that data be used to either support the
- 20 preliminary investigation of safety-related defects or to
- 21 support defect investigations that have been launched in some
- 22 way and it would admit that there is a lot of interest in

- 1 upgrading the data safety-related defects investigation
- 2 process. The administrator has come out and said only 100
- 3 percent compliance is acceptable. And there has been some
- 4 discussion about, again, the use of connected vehicle sensors
- 5 and so forth, all sorts of data that might be able to support
- 6 those investigations in the future.
- 7 I am not sure if that is actually within the scope of this
- 8 effort or not but I wanted to throw it out there.
- 9 VICE CHAIR WILKERSON: Well, thank you so much, Peter. I
- 10 also had raised some comments about other nontraditional data
- 11 that will be linked to the car through mobile and other devices
- 12 or aftermarket. There are things like RFID, tags that are being
- 13 put on multiple devices, like tires and other things that house
- 14 that data, will be shared or what the intent is for how that
- 15 information might be related to the public and otherwise.
- So, we have a couple of other topics that we can discuss
- 17 and hopefully, Bob, we can maybe have one more call or at least
- 18 have some detailed email exchanges.
- 19 MEMBER DENARO: No, I think we definitely want to have a
- 20 call so we talk through it.
- 21 Peter, back to your comment on the second one, use of
- 22 connected data for safety-related defects, are you talking

- 1 about attempting to predict defects or diagnose defects or both?
- 2 MEMBER KISSINGER: It could be both. It could be early
- 3 identification or once there was some initial investigation
- 4 started, it could be used to explore whether that was real or
- 5 not. It could be used in any sort of phase of the investigation
- 6 from early identification to more comprehensive validation of
- 7 the problem.
- 8 MEMBER DENARO: Right. Okay, that makes sense.
- 9 And Sheryl, just a question for you, then, on your comment,
- 10 so I understand it. Are you talking about the fact that okay,
- 11 we have got embedded systems and official mandated V2V and V2I
- 12 system and we are going to come up with some policies on sharing
- 13 that data, are you saying that we have just been silent on what
- 14 about various aftermarket devices that might be marketed? Are
- 15 you talking about some policy there or the ability of the server
- 16 to handle that data?
- 17 VICE CHAIR WILKERSON: I think the fact is from what I am
- 18 reading and what I am seeing is that there will be other kinds
- 19 of data that will have some relationship. So, they might be
- 20 connected through embedded. They might have some external
- 21 contacts. For instance, I know we are looking at helmets and
- 22 other things. But there are other parts of the vehicle that

- 1 will be attached. I don't know how that data is going to
- 2 communicate -- whether it is going to be linked to the connected
- 3 vehicle or whether it will be separate but there will be other
- 4 kinds of information that will provide safety information.
- 5 MEMBER DENARO: So, does the question have to do with the
- 6 ability of the server that is behind all of this and handling
- 7 all of this connected vehicle to also to be able to interact
- 8 with these aftermarket --
- 9 VICE CHAIR WILKERSON: Yes, I think that is the issue.
- 10 Will we be looking at that or will they be separate and apart.
- 11 MEMBER DENARO: Got it. All right, thanks.
- 12 VICE CHAIR WILKERSON: And I am happy to try to draft
- 13 something to send to you for --
- 14 MEMBER DENARO: What I think I will do is I will come back
- 15 both to you, Peter, and Sheryl, in terms of you are the one with
- 16 the idea. If you could jot down a short paragraph just like
- 17 we have in the document, then that will be helpful to get it
- 18 in there.
- 19 Funding/Public-Private Partnership Subcommittee Update
- 20 VICE CHAIR WILKERSON: Okay. We will certainly do that
- 21 well before the deadline.
- Okay, so if there are no more questions, we will move to

- 1 Ginger.
- 2 MEMBER GOODIN: All right, good. This is Ginger Goodin and
- 3 we are not quite as far as along as Bob's subcommittee in terms
- 4 of formulating recommendations but we have had a conference call
- 5 and we have had some kind of individual conversations about
- 6 this. And I think what I will do is share a little bit of
- 7 information about kind of the background of the issues here,
- 8 as well as some issues that we think will be the starting point
- 9 of formulating some recommendations.
- 10 So first of all, for a little bit of background on the
- 11 funding and the role of P3s, where we start is that the state
- 12 and local agencies, with the support from the federal aid
- 13 programs, and using their own funding, they are responsible for
- 14 the capital and operating costs for connected vehicle and ITS
- 15 implementation. Traditionally for ITS, the ongoing operations
- 16 and maintenance in paying for that has been a key concern.
- So, what we have going on right now is the transportation
- 18 funding, both the capacity for funding, as well as the
- 19 sustainability of the funding. That is a significant challenge
- 20 at all levels of government, federal, state, and local. And
- 21 with state and local agencies, funding a significant part of
- 22 infrastructure costs and picking up a growing share of the

- 1 shrinking federal contribution, that is where kind of the
- 2 sticking point is.
- 3 So, what we are seeing then is if the funding part isn't
- 4 getting bigger, then ITS is going to be required -- and connected
- 5 vehicle implementation will require a bigger slice of the pie
- 6 that is shrinking. And that means they are going to be
- 7 competing with traditional transportation strategies. And
- 8 that is going to be even more challenging as the funding gaps
- 9 are.
- 10 I think that at the August meeting Bob Rupert talked a
- 11 little about a report that was just issued at that time called
- 12 Use of Incentives for Encouraging ITS Deployment and we have
- 13 looked at that. And the report addresses a lot of ways that
- 14 USDOT can incentivize deployment. And I think that report is
- 15 a good foundation and a basis for further discussion on the
- 16 topic.
- What we think are the gaps, though, that aren't represented
- 18 in the report are three main areas. One is when we talk about
- 19 a lot of quantifying the cost and benefits and the significant
- 20 role that plays because there has to be a clear value proposition
- 21 for investing transportation dollars in a different way to
- 22 support connected vehicle and ITS.

- 1 So, while the report addresses evaluating benefits and
- 2 costs, and I think what we need to do is move behind kind of
- 3 -- we have to do the standard performance measures looking at
- 4 the mobility safety environment. We also have to look at what
- 5 is the opportunity that ITS presents versus other
- 6 transportation strategies that have been competing for this
- 7 shrinking pie.
- 8 And I think this may involve a bigger discussion about how
- 9 states are filling the gap and the role of federal government
- 10 in the funding.
- 11 The public-private partnership, where this comes in is if
- 12 we have this funding gap, what is the role of P3s? We have seen
- 13 this used successfully in traditional infrastructure. What is
- 14 the role, then, possibly for connected vehicle and ITS? So,
- 15 we think that that should be explored some more.
- And then finally, the third aspect of the communication
- 17 outreach to policy makers because this isn't resonating with
- 18 a lot of the policy makers, particularly at state and local
- 19 level. How do we make this real to policy makers because this
- 20 involves a new way of investing and a new approach to decision
- 21 making? And so the outreach and communication plays a role
- 22 there.

- 1 So, that is our thinking at this point and I think -- let
- 2 me just confirm the date. You said July 17th?
- 3 VICE CHAIR WILKERSON: Yes, for initial drafts of your
- 4 report, so the various subcommittee reports.
- 5 MEMBER GOODIN: Okay. So, I think working from this, and
- 6 I will let some other subcommittee members chime in if they have
- 7 anything else, but I think we have got a starting point and I
- 8 think the July 17th date is doable to get recommendations in.
- 9 Does anybody else from the subcommittee have anything they
- 10 want to add?

### 11 Scenario Planning Subcommittee Update

- 12 VICE CHAIR WILKERSON: Okay. All right, then we will move
- 13 on to the Scenario Planning, Scott.
- 14 MEMBER MCCORMICK: Yes, we weren't able to schedule a call.
- 15 I only ever had Roger Berg and Raj for one and somebody else
- 16 for another one of the eight times that we picked.
- 17 And the weird thing is nobody literally responded. It
- 18 wasn't that they said they couldn't make any of those dates.
- 19 They just didn't really respond.
- So, I sent out a couple of emails on it and never got any
- 21 more traction on it. So, I am going to do that again early next
- 22 week and try to get one scheduled before the meeting on the 17th.

- 1 VICE CHAIR WILKERSON: Okay.
- 2 MEMBER DENARO: Scott, this is Bob. A little piece of
- 3 advice for you. I had the same problem, nobody was responding
- 4 to my requests for a meeting. So, I just scheduled it anyway
- 5 and everyone showed up.
- 6 MEMBER MCCORMICK: I may just try that.
- 7 VICE CHAIR WILKERSON: Okay. So, why don't we go ahead?
- 8 Thanks so much, Scott, and we look forward to getting your input.
- 9 Public Transportation Subcommittee Update
- 10 Why don't we move to Joe for Public Transportation?
- 11 MEMBER CALABRESE: Yes, thanks. I actually lost my notes
- 12 until this morning. But the great news is that the notes we
- 13 took at our last meeting in February were very complete and I
- 14 have got them better organized.
- I haven't yet called my first meeting and will be doing that
- 16 very soon.
- One of the outstanding issues, again, that I did not follow
- 18 up on until today was to contact Ken. One of our questions was
- 19 what is USDOT really working on with respect to making public
- 20 transit safer, more attractive, more productive, particularly
- 21 we want to get a better idea of what is out there today. What
- 22 is the status of the current programs we are working on right

- 1 now through FTA, before we can move forward?
- I think we are in pretty good shape. I think we can have
- 3 a very good meeting.
- 4 The other thing we want to be able to do also was to look
- 5 at how to coordinate with what we are doing in Public Transit
- 6 with the Shared Use Committee. So, again, I will reach out to
- 7 Susan to see where they are with that as well.
- 8 VICE CHAIR WILKERSON: Okay, great. Any more comment?
- 9 Is this something that we need to have a discussion or a
- 10 presentation on in August or you assuming that you will have
- 11 more information and you will work on that?
- MEMBER CALABRESE: I think we will be very much ready to
- 13 get you something surely before July and have a presentation
- 14 in August.
- 15 VICE CHAIR WILKERSON: Okay, great. Thank you. Any
- 16 other comments on Public Transportation?
- 17 Shared Use Subcommittee Update
- Okay, well, we will move to Susan, Shared Use. Susan, are
- 19 you on?
- 20 MEMBER SHAHEEN: Hi, this is Susan. Can you hear me?
- 21 VICE CHAIR WILKERSON: Yes, we can.
- MEMBER SHAHEEN: I was muted because I am driving. So, I

- 1 --
- VICE CHAIR WILKERSON: Well, be careful.
- MEMBER SHAHEEN: Yes. I have not yet called a meeting, in
- 4 part because I wasn't entirely sure what I was supposed to do
- 5 because I missed the February meeting.
- I think I can get us caught up. It sounds like we are tasked
- 7 with us writing recommendations for the Joint Programs Office
- 8 on how to proceed in the area of shared mobility. Is that
- 9 correct?
- 10 VICE CHAIR WILKERSON: Yes.
- 11 MEMBER SHAHEEN: Okay, great. So, I would imagine that we
- 12 probably want to look at the role of government, also the role
- 13 of the services and, potentially, filling gaps in the public
- 14 transportation system, as well as filling funding gaps that
- 15 exist that I think Ginger mentioned. And I think a whole series
- 16 of this phase would be very, very helpful to examine in the
- 17 context of -- sorry, I am a little distracted at the moment.
- 18 VICE CHAIR WILKERSON: Don't be distracted.
- 19 MEMBER SHAHEEN: Sorry, just a lot of traffic here.
- 20 So, I will be looking at that those type of recommendations,
- 21 along with the subcommittee. And it shouldn't be a problem,
- 22 I think, to gather the group together prior to the July 17th

- 1 meeting and to pull those recommendations together.
- 2 VICE CHAIR WILKERSON: Okay. Well, thank you so much and
- 3 please drive safely.
- 4 Is there anyone else from the Shared Use Committee that has
- 5 questions or comments or additions?
- 6 You may recall Susan gave a really great presentation
- 7 earlier but was unable to participate in the meeting.
- No? Okay. We don't have a freight and intermodal, so we
- 9 agreed not to do that.
- 10 One question I had, and this is for you Scott McCormick,
- 11 we had talked about the scenario planning and I think there had
- 12 been some discussion that there might be some various scenarios
- 13 that would come out of the other four subcommittees. Is that
- 14 likely?
- 15 MEMBER MCCORMICK: Yes, that was -- from what I am hearing
- 16 from the other subcommittees, I think that is very likely.
- 17 VICE CHAIR WILKERSON: Okay.
- MEMBER MCCORMICK: And so what we will probably do is we
- 19 will make this effort a two-parter, with the first part that
- 20 just says here is the framework that we think ought to be
- 21 exercised on or suggest exercising.
- 22 And then as we get the readouts from everybody's committee

- 1 reports, then we can go back and refine it and say well, maybe
- 2 should we add this or that, and collecting the committee that
- 3 is likely to do.
- 4 VICE CHAIR WILKERSON: Okay, great.
- 5 MEMBER MCCORMICK: I think that is a great idea.
- 6 VICE CHAIR WILKERSON: Okay, great.
- 7 Any other questions? Are there any other changes to the
- 8 subcommittee members? Anyone who would like to be on another
- 9 committee? If so, please let us know. If you have looked at
- 10 the materials that were put on the ITSPAC website, they do have
- 11 the transcript and they have the preliminary chart.
- So, Steve, I am thinking we might want to get an update for
- 13 that chart circulated prior to the next meeting.
- 14 MR. GLASSCOCK: Will do.
- 15 VICE CHAIR WILKERSON: Just for the record.
- 16 MR. GLASSCOCK: Sure.
- 17 VICE CHAIR WILKERSON: Okay. And also, we can add Steve
- 18 and Peter to that chart, and myself on the Data Committee.
- 19 Next Steps
- So, if there is no further discussion on the subcommittees,
- 21 then next steps is that the subcommittees will prepare their
- 22 initial drafts of their reports by July 17, 2015.

- 1 Also, in looking at our time line, the time line that Steve
- 2 provided some time ago, the second advice memo will be due to
- 3 ITS JPO in September of 2015. That will follow our August 13
- 4 meeting, our face-to-face meeting that will be in Washington
- 5 and held at one of the Marriotts in Crystal City.
- 6 Any other -- anything else we need to know with respect to
- 7 the time frame, Steve?
- 8 MR. GLASSCOCK: No, you covered it very well. We are going
- 9 to send out the travel instructions probably for the August
- 10 meeting in the next week or so.
- 11 VICE CHAIR WILKERSON: Okay, great.
- 12 MEMBER DENARO: Is that a one-day meeting, Steve?
- 13 MR. GLASSCOCK: Yes, it is.
- 14 MEMBER DENARO: Okay.

### 15 Review of Action Items

- 16 VICE CHAIR WILKERSON: Okay, any other action items or
- 17 other topics? We have some time.
- 18 No? If not, then that is all I have for the schedule and
- 19 a review of the action items. I will review my notes and take
- 20 these into consideration when we work with Steve to prepare the
- 21 agenda for the next meeting.
- 22 MR. GLASSCOCK: And --

- 1 MEMBER MCCORMICK: Sheryl, I was going to ask -- sorry. Go
- 2 ahead.
- MR. GLASSCOCK: That's all right. I was just going to say,
- 4 as always, any ideas or things that you would like to discuss
- 5 for the agenda for the August meeting, please send Sheryl and
- 6 I a note and we will make sure to include it.
- 7 MEMBER MCCORMICK: Great minds think alike because that is
- 8 what I just was going to suggest. Because like we did at the
- 9 other meeting, we had a couple of people like Walt and it would
- 10 be good to have the connected vehicle and capacity building guys
- 11 come up and give an update on where they are because I know they
- 12 were kind of preliminary.
- So yes, if we have time in the agenda, was going to be my
- 14 questions, when you get a straw agenda, if we know that we have
- 15 got an hour or two or an hour, hour and half or whatever to plug
- 16 in some half-hour updates by some D.C. folks that might really
- 17 useful.
- 18 VICE CHAIR WILKERSON: Great. I think the key will be able
- 19 to have as much of the reports in as best we can or as fleshed
- 20 out as much as we can so that we can have a really productive
- 21 meeting in August.
- 22 Before we close, I wanted to just make sure that I didn't

- 1 miss anyone who was not on the call earlier when we did the roll
- 2 call. I did not have Scott Belcher, Raj, and -- was there one
- 3 other person? I knew George could not be on, he had a conflict.
- 4 MEMBER KENNER: Steve Kenner.
- 5 VICE CHAIR WILKERSON: Yes, and Steve. I have Steve.
- 6 MEMBER DENARO: Sheryl, this is Bob. You didn't have me
- 7 initially but, as you can tell, I joined in.
- 8 VICE CHAIR WILKERSON: Yes, thank you.
- 9 Well, I have no other comments. If there are no other
- 10 comments or additions, we can adjourn the meeting.

## 11 Adjourn

- MR. GLASSCOCK: Yes, so Ken asked me to just -- I just sent
- 13 an email out with the very interesting article that was in the
- 14 Washington Post that I think you all will find interesting, if
- 15 you haven't had a chance to read it.
- So, with that, thank you everyone and we will see you in
- 17 August in D.C.
- 18 VICE CHAIR WILKERSON: All right. And thank you, Egan, and
- 19 congratulations to Jeff. And good luck with your other
- 20 searches.
- 21 MR. GLASSCOCK: Thank you.
- 22 VICE CHAIR WILKERSON: Okay. Bye-bye. Thanks,
