 - Describes that non contractible activities are funded out of the funds identified in 23 USC 202(a)(6) (IE: PM&O) and can be used only by BIA and FHWA and identifies that these can be found in the Appendix to this Subpart
 - · § 170.614
 - Updated to reflect that tribes may receive partial funding as that funding becomes available to FHWA and BIA (IE: Continuing Resolutions and Extensions)
 - § 170.615 618
 - Updates: the availability of advance payments, receiving additional funds if they become available to the TTP on a nationwide basis, contingencies, and savings to align with new statutes.

 - Identifies when tribal preference and Indian preference apply to TTP. No changes other than Program Agreements was added as a reference.
