**Success story:** The Metro Access Path on Galloway Street NW, Facilities for Pedestrians & Bicycles in Rock Creek Park Project — A unit of the National Park Service, Rock Creek Park is a major tourism destination and important economic engine in the District of Columbia.

This project will construct a 10-foot wide multi-use trail along Galloway Street to reduce the creation and use of social trails through Federal land areas that are intended to remain natural green space. The project will construct 600 linear feet of new trail to connect the Fort Totten Metro Rail station with the surrounding neighborhoods. Retaining and drainage structures will be constructed as necessary. Retaining structures will be constructed of natural stone or approved material that looks like natural stone to fit into the park setting. The multi-use trail will be designed to DDOT standards. This project will provide for a safe, properly maintained, lighted pathway that also links to public transportation. The National Park Service will benefit in the opportunity to tell the story of the Civil War Defenses of Washington using wayside signs while preserving the resource.



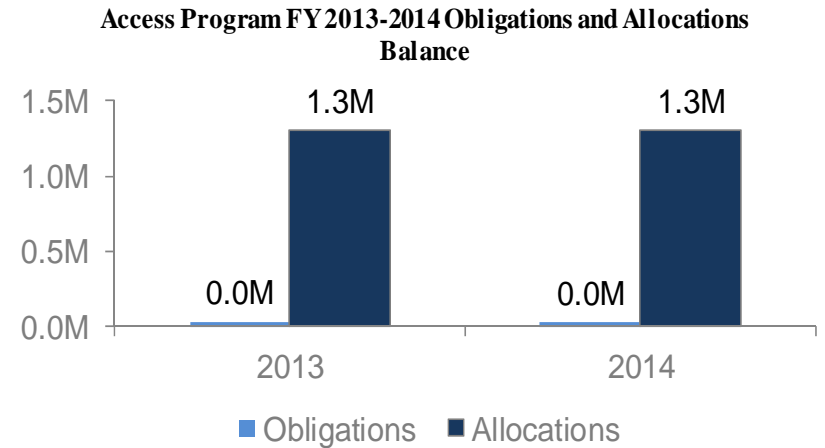

### FLAP Project Selection Process

Each FLAP project was selected from a pool of applications submitted by the facility owner in response to a state-wide call for projects. The applications were screened, rated, and ranked using PDC approved rating criteria. The PDC unanimously agreed which projects met the established State program goals and conformed with the project ranking criteria contained in the “Call for Projects SOP”. Based upon these evaluations, the proposed projects were recommended for programming within the available funding for each state. Memorandum of Agreements (MOA) were coordinated and executed for each programmed project prior to obligation of FLAP funds. There was one call for projects, from August 19, 2013 until November 4, 2013, that generated 3 applications totaling \$1,156,000 funds requested.
