
Success Story: Swain County, North Carolina-The project will construct a small helipad in a remote area of Swain County near the Nantahala National Forest-Tsali Forest Service Recreation Area and on the border of Swain and Graham County. This project will significantly enhance mobility for emergency situations for safe landing of a helicopter and provide a more feasible way to the hospitals that are located 2- hours away by vehicle.

The Tsali Recreation Area Helipad project will consist of preliminary engineering, construction engineering services, and construction of the helipad. The project will construct a 60-foot by 60-foot concrete helipad. A 200-foot long by 10-foot wide concrete path with a small turning area will be constructed to provide vehicular access to the helipad from NC 28.

This centrally-located helipad will provide visitors with quick, life saving emergency response access for National Forest users such as: motorcyclists, campers, bicyclists, hikers, horseback riders and rafters. By increasing a safe reputation this project may also positively impact the economies for Swain and Graham counties by attracting visitors, recreation associations and new tourism-based small businesses.




Swain County Helipad, North Carolina

FLAP Project Selection Process

Each FLAP project was selected from a pool of applications submitted by the facility owner in response to a state-wide call for projects. The applications were screened, rated, and ranked using PDC approved rating criteria. The PDC unanimously agreed which projects met the established State program goals and conformed with the project ranking criteria contained in the "Call for Projects SOP." Based upon these evaluations, the proposed projects were recommended for programming within the available funding for each State. Memorandum of Agreements (MOA) were coordinated and executed for each programmed project prior to obligation of FLAP funds. There was one call for projects, from July 19, 2013, until October 31, 2013, that generated twelve applications totaling \$7,045,400 funds requested.
