**Success Story:** South Carolina State Highway Route 248 is a rural major collector roadway that serves as primary access to this National Historic Site. The project termini will be between US Route 178 and State Secondary Road S-24-72 (Johnston Rd.) in Ninety Six. The SCDOT resurfacing, road safety, and design standards will be used for this project.

The overall design concept includes: milling the existing asphalt surface course to remove oxidized and rutted pavement, full depth patch base failures as necessary, construction of two foot paved safety shoulders, installation of guardrail at three locations that meet barrier warrants including the bridge over Ninety Six Creek.

The project will provide the park visitors and locals with a more safe and accessible route to National Park from Greenwood or Saluda counties. This project will attract visitors and tourism when visiting Lake Greenwood State Park and Star Fort fishing pond and other recreational activities.



## FLAP Project Selection Process

Each FLAP project was selected from a pool of applications submitted by the facility owner in response to a state-wide call for projects.. The applications were screened, rated, and ranked using PDC approved rating criteria. The PDC unanimously agreed which projects met the established State program goals and conformed with the project ranking criteria contained in the "Call for Projects SOP." Based upon these evaluations, the proposed projects were recommended for programming within the available funding for each state. Memorandum of Agreements (MOA) were coordinated and executed for each programmed project prior to obligation of FLAP funds. There was one call for projects, from August 1, 2013, until September 6, 2013, that generated eleven applications totaling \$10,722,569 funds requested.
