**Success Story:** The Trail Community Connections - Mount Tom Gateway Phase 1 project consist of the repairs to the existing stone works that support a one mile portion of the Mount Tom Gateway trail tread way in the Town of Woodstock, Vermont. The trail is a major pedestrian gateway to the Marsh-Billings-Rockefeller National Historical Park and connects to Billings Park, Faulkner Park and Woodstock Village.

The trail is 4 feet wide, gains 400 feet in elevation, and never exceeds a 5 percent slope. The project work includes reconstruction of existing stone cribbing and stone retaining walls, restoration of the edge stones delineating the trail, rebuilding damaged stone culverts to improve drainage, and other miscellaneous work.

Restoration to this trail will improve safety for visitors and improve access to the park and surrounding landscapes. The trail is frequently listed in hiking guides and travel magazines as a family friendly trail. The National Park typically hosts over 30,000 visitors each season.

## **FLAP Project Selection Process**

Each FLAP project was selected from a pool of applications submitted by the facility owner in response to a state-wide call for projects. The applications were screened, rated, and ranked using PDC approved rating criteria. The PDC unanimously agreed which projects met the established State program goals and conformed with the project ranking criteria contained in the "Call for Projects SOP". Based upon these evaluations, the proposed projects were recommended for programming within the available funding for each state. Memorandum of Agreements (MOA) were coordinated and executed for each programmed project prior to obligation of FLAP funds. There was one call for projects, from July 1, 2013 until August 16, 2013, that generated three applications totaling \$509,906 funds requested.
