DOT-E 7040 (FIRST REVISION)

- 1. Polaroid Corporation, Needham, Massachusetts, is hereby granted an exemption from those provisions of this Department's Hazardous Materials Regulations specified in paragraph 5 below to offer packages prescribed herein of a certain corrosive liquid for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes the carriage of larger quantities of corrosive liquids than presently authorized by cargo-only aircraft, and provides no relief from any regulation other than as specifically stated.
- 2. <u>BASIS</u>. This exemption is based on Polaroid Corporation's application dated March 13, 1978, submitted in accordance with 49 CFR 107.105 and the public proceeding thereon.
- 3. <u>HAZARDOUS MATERIALS (Descriptor and class)</u>. Film developer having viscosity in the range of 50,000 to 200,000 centipoises.
- 4. PROPER SHIPPING NAME (49 CFR 172.101). Corrosive liquid, n.o.s.
- 5. REGULATION AFFECTED. 49 CFR 172.101, 175.3.
- 6. MODE OF TRANSPORTATION AUTHORIZED. Cargo-only aircraft.
- 7. SAFETY CONTROL MEASURES. Packaging prescribed is a 55-gallon DOT Specification 6D cylindrical steel overpack with inside DOT Specification 2SL container mounted on a pallet and covered with a wooden overwrap.
- SPECIAL PROVISIONS.
 - a. Persons who receive packages covered by this exemption may reship them pursuant to the provisions of 49 CFR 173.22a.
 - b. A copy of this exemption must be carried aboard each aircraft used to transport packages covered by this exemption.
- 9. <u>REPORTING REQUIREMENTS</u>. Any incident involving loss of contents of the package must be reported to the Office of Hazardous Materials Regulation as soon as practicable.
- 10. EXPIRATION DATE. June 15, 1980.
