

ADVISORY

IF YOU ARE A HOLDER OF AN EXEMPTION THAT AUTHORIZES THE USE OF A PACKAGING WITH A MAXIMUM CAPACITY LESS THAN 450 L (119 GALLONS) OR A MAXIMUM NET MASS LESS THAN 400 KG (882 POUNDS), PLEASE BE ADVISED THAT YOUR EXEMPTION MAY NOT BE RENEWED BEYOND SEPTEMBER 30, 1996. IN ADDITION, NO NEW CONSTRUCTION OF PACKAGINGS WHICH FALL WITHIN THE NON-BULK CAPACITIES LISTED ABOVE ARE AUTHORIZED AFTER SEPTEMBER 30, 1994. THIS IS CONSISTENT WITH THE IMPLEMENTATION OF THE NEW PACKAGING REQUIREMENTS ADOPTED UNDER DOCKET HM-181. ANY APPLICATION SUBMITTED TO THIS OFFICE TO RENEW AN EXEMPTION BEYOND THE SEPTEMBER 30, 1996 DATE WILL BE DENIED UNLESS THE APPLICATION CONTAINS SUPPORTING INFORMATION TO JUSTIFY THE CONTINUATION OF THE EXEMPTION.

DOT-E 7730 (SECOND REVISION)

JUL 28 1987

- 1. Western Company of North America, Fort Worth, Texas, is hereby granted an exemption from those provisions of this Department's Hazardous Materials Regulations specified in paragraph 5 below to transport packages prescribed herein of certain corrosive materials for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes use of a DOT Specification MC-312 cargo tank, and provides no relief from any regulation other than as specifically stated.
- 2. BASIS. This exemption is based on Western Company of North America's application dated July 31, 1986, submitted in accordance with 49 CFR 107.105 and the public proceeding thereon.
- 3. HAZARDOUS MATERIALS (Descriptor and class). Acetic acid, 10% by weight; Hydrochloric acid, 15% to 28% by weight; Hydrofluoric acid, 6% by weight, classed as corrosive materials.
- 4. PROPER SHIPPING NAME (49 CFR 172.101). Acetic acid, Hydrochloric acid, Hydrofluoric acid solution, as appropriate.
- 5. REGULATION AFFECTED. 49 CFR 178.343-5(b)(2)(ii).
- 6. MODE OF TRANSPORTATION AUTHORIZED. Motor vehicle.
- 7. SAFETY CONTROL MEASURES. Packaging prescribed is a DOT Specification MC-312 cargo tank except that the bottom discharge valve must be equipped with a remote means to actuate a valve closure manually from a point no less than 4.0 feet away when tank design and length do not provide for the required 10.0 feet.

8. SPECIAL PROVISIONS.

- a. A copy of this exemption must be carried aboard each motor vehicle used to transport packages covered by this exemption.
- b. Each cargo tank must be plainly marked on the right side near the front, in letters at least two inches high on a contrasting background, "DOT-E 7730."
- 9. REPORTING REQUIREMENTS. Any incident involving loss of contents of the package must be reported to the Office of Hazardous Materials Transportation as soon as practicable.
- 10. EXPIRATION DATE. June 1, 1989.
