- 1. E.I. Du Pont De Nemours & Company, Wilmington, Delaware is hereby granted an exemption from those provisions of this Department's Hazardous Materials Regulations specified in paragraph 5 below to offer packages prescribed herein of a corrosive material for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes the shipment of hydrogen fluoride in DOT Specification 112A400W tank cars stenciled DOT-112A200W, and provides no relief from any regulation other than as specifically stated.
- 2. BASIS. This exemption is based on E.I. Du Pont De Nemours and Company's application dated May 16, 1984 and submitted in accordance with 49 CFR 107.103 and the public proceeding thereon.
- 3. <u>HAZARDOUS MATERIALS (Descriptor and class)</u>. Hydrogen fluoride; corrosive material.
- 4. PROPER SHIPPING NAME (49 CFR 172.101). Hydrogen fluoride.
- 5. REGULATION AFFECTED. 49 CFR 173.264(b)(2), 179.101-1(a).
- MODES OF TRANSPORTATION AUTHORIZED. Rail freight.
- 7. SAFETY CONTROL MEASURES. Packaging prescribed is DOT Specification 112A400W tank cars stenciled DOT 112A200W. The combination relief device of the tank is set in accordance with 112A200W tank car specification and 49 CFR 179,100-15(c).
- 8. SPECIAL PROVISIONS.
 - a. Persons who receive packages covered by this exemption may reship them pursuant to provisions of 49 CFR 173.22a.
- 9. <u>REPORTING REQUIREMENTS</u>. Any incident involving loss of contents of the package must be reported to the Office of Hazardous Materials Regulation as soon as practicable.
- 10. EXPIRATION DATE. August 1, 1986.
