

8. SPECIAL PROVISIONS.

a. Persons who receive the packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with, and a current copy of this exemption is maintained at each facility from which such reoffering occurs.

b. A copy of this exemption must be carried aboard each motor vehicle and vessel used to transport packages covered by this exemption.


c. Each multi-unit tank car tank must be plainly marked on both sides near the middle, in letters at least four inches high on contrasting background, "DOT-E 9282".

d. Prior to the first shipment of rail freight, a copy of the Tank Car Committee (AAR) approval, as required by Section 173.31(a)(4), must be on file with the OHMEA.

9. REPORTING REQUIREMENTS. Any incident involving loss of packaging contents or packaging failure must be reported to the Associate Administrator for Hazardous Materials Safety as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.)

10. EXPIRATION DATE. April 30, 1992.
