ADVISORY

IF YOU ARE A HOLDER OF AN EXEMPTION THAT AUTHORIZES THE USE OF A PACKAGING WITH A MAXIMUM CAPACITY LESS THAN 450 L (119 GALLONS) OR A MAXIMUM NET MASS LESS THAN 400 KG (882 POUNDS), PLEASE BE ADVISED THAT YOUR EXEMPTION MAY NOT BE RENEWED BEYOND SEPTEMBER 30, 1996. IN ADDITION, NO NEW CONSTRUCTION OF PACKAGINGS WHICH FALL WITHIN THE NON-BULK CAPACITIES LISTED ABOVE ARE AUTHORIZED AFTER SEPTEMBER 30, 1994. THIS IS CONSISTENT WITH THE IMPLEMENTATION OF THE NEW PACKAGING REQUIREMENTS ADOPTED UNDER DOCKET HM-181. ANY APPLICATION SUBMITTED TO THIS OFFICE TO RENEW AN EXEMPTION BEYOND THE SEPTEMBER 30, 1996 DATE WILL BE DENIED UNLESS THE APPLICATION CONTAINS SUPPORTING INFORMATION TO JUSTIFY THE CONTINUATION OF THE EXEMPTION.

1. Texas Alkyls, Deer Park, Texas, is hereby granted an exemption from those provisions of this Department's Hazardous Materials Regulations specified in paragraph 5 below to offer packages prescribed herein of a flammable liquid for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes DOT Specification 4BA240 and 4BW240 cylinders to be hydrostatically retested every ten years, rather than every five years, when used solely for the shipment of non-corrosive, metal alkyl solutions, and provides no relief from any regulation other than as specifically stated.

2. BASIS. This exemption is based on an application from Stauffer Chemical Company dated July 9, 1987, submitted on behalf of Texas Alkyls, in accordance with 49 CFR 107.105 and the public proceeding thereon.

3. HAZARDOUS MATERIALS (Descriptor and class). Metal alkyl, solution, n.o.s., classed as a flammable liquid.

4. PROPER SHIPPING NAME (49 CFR 172.101). Metal alkyl, solution, n.o.s.

5. REGULATION AFFECTED. 49 CFR Part 107, Appendix B; 173.34(e).

6. MODE OF TRANSPORTATION AUTHORIZED. Motor vehicle and cargo vessel.

7. SAFETY CONTROL MEASURES. Packagings prescribed are DOT Specifications 4BA240 and 4BW240 cylinders. The cylinders are authorized to be hydrostatically retested every 10 years, rather than every five years when used only for the shipment of non-corrosive, metal alkyl solutions.

8. SPECIAL PROVISIONS.

a. Persons who receive packages covered by this exemption may reship them pursuant to the provisions of 49 CFR 173.22a.

b. The requirements of Part 107, Appendix B(1) involving marking the exemption number on the cylinders, does not apply.


c. Prior to each loading, cylinders must be given a complete external visual inspection.

d. A copy of this exemption must be carried aboard each motor vehicle and cargo vessel used to transport packages covered by this exemption.

9. REPORTING REQUIREMENTS. Any incident involving loss of contents of the package must be reported to the Office of Hazardous Materials Transportation as soon as possible.

10. EXPIRATION DATE. July 31, 1989.
