DOT-E 9983

- 1. Explosive Technology, Fairfield, California, is hereby granted an exemption from certain provisions of this Department's Hazardous Materials Regulations to offer packages prescribed herein of a Class A explosive for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes the use of a wooden box having a gross weight exceeding that authorized in the regulations, and provides no relief from any regulation other than as specifically stated.
- 2. <u>BASIS</u>. This exemption is based on an application from Explosive Technology dated April 13, 1988, submitted in accordance with 49 CFR 107.103 and the public proceeding thereon.
- 3. HAZARDOUS MATERIALS (Descriptor and class). High explosive, Class A explosive.
- 4. PROPER SHIPPING NAME (49 CFR 172.101). High explosive.
- REGULATION AFFECTED. 49 CFR 173.65(a)(4).
- MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle.
- 7. SAFETY CONTROL MEASURES. Packaging prescribed is a DOT Specification 15A wooden box with a maximum gross weight of 400 pounds.
- 8. SPECIAL PROVISIONS.
 - a. Persons who receive packages covered by this exemption may reship them pursuant to the provisions of 49 CFR 173,22a.
- 9. REPORTING REQUIREMENTS. Any incident involving loss of contents of the package must be reported to the Office of Hazardous Materials Transportation as soon as practicable.
- 10. EXPIRATION DATE. July 31, 1990.
