DOT-E 10203 (FIRST REVISION)

- 1. Thiokol Corporation, Marshall, Texas, is hereby granted an exemption from certain provisions of this Department's Hazardous Materials Regulations to offer packages prescribe herein of Ammunition, illuminating, Division 1.3C for transportation commerce subject to the limitations and special requirements specified herein. This exemption authorizes the transportation of 155mm Ammunition, illuminating in non-DOT packaging, and provides no relief from a regulation other than as specifically stated. Reference to 49 CFR sections in this exemptions are to regulations in effect on September 30, 1991.
- 2. <u>BASIS.</u> This exemption is based on an application from Thiokol Corporation dated February 16, 1994, submitted in accordance with 49 CFR 107.105.
- 3. <u>HAZARDOUS MATERIALS (Descriptor and class).</u> Ammunition Illuminating Division 1.3G, UN0254, EX Number 9306109.
- 4. PROPER SHIPPING NAME (49 CFR 172.101). Ammunition, illuminating.
- 5. REGULATION AFFECTED. 49 CFR 173.91.
- 6. MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle and cargo vessel.
- 7. <u>SAFETY CONTROL MEASURES.</u> Packaging prescribed is palletization, 8 rounds per pallet, in accordance with Department of Defense (DOD) drawing identified as ARDC 8837839 dated July 23, 1973, on file with the application in the Office of Hazardous Materials Exemptions and Approvals (OHMEA).

8. SPECIAL PROVISIONS.

- a. Shipment must:
 - 1. Be prepared and offered to the carrier in accordance with DOD safety requirements.
 - Originate at Longhorn Army Ammunition Plant, destined for a port of export.
 - 3. Be made in truckload lots.
- b. In lieu of 49 CFR Part 107, Appendix B (1), each motor vehicle must be conspicuously marked on the right side, near the front, in letters at least 2 inches high, "DOT-E 10203".
- c. A copy of this exemption must be carried aboard each motor vehicle and cargo vessel used to transport packages covered by this exemption.

- d. No new construction of this packaging identified in paragraph 7 of this exemption is authorized after September 30, 1994. As the holder of this exemption, you may request a renewal to continue the use of the packaging manufactured prior to September 30, 1994. however, the exemption will not carry an expiration date subsequent to September 30, 1996 since use of the packaging is prohibited after that date. This is consistent with the transitional provision of 49 CFR Section 171.14 and the implementation of the new packaging requirements adopted under Docket HM-181.
- 9. REPORTING REQUIREMENTS. The carrier is required to report any incident involving fire, explosion or loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Material Safety as soon as practicable. [49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.] In addition, the holder(s) of this exemptions must inform AAHMS, in writing, of any incidents involving the package and shipment made under the terms of this exemption.
- 10. EXPIRATION DATE. March 31, 1996.
