- 7. PACKAGING AND SAFETY CONTROL MEASURES.
 - a. <u>PACKAGING</u>. Packaging prescribed is a DOT Specification 4BW cylinder, which is used exclusively for triethylamine (free from corroding compounds).
 - b. <u>TESTING</u>. Each cylinder must be retested, reinspected, and marked as prescribed in 49 CFR 179.34(e)(10).
 - c. MARKING. Each cylinder must be plainly and durably marked "DOT E-10651".
- 9. MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle.
- 10. MODAL REQUIREMENTS. None as a requirement of this exemption.
- 11. <u>COMPLIANCE</u>. Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Hazardous Materials Transportation Act:
 - All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, Parts 171-180.
 - o Registration required by 49 CFR 107.601 et seq., when applicable.

Any use or application of this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect unless a regulation has been amended making the exemption no longer necessary.

12. <u>REPORTING REQUIREMENTS</u>. The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must also inform the AAHMS, in writing, as soon as practicable of any incidents involving the package and shipments made under this exemption.
