ADVISORY

IF YOU ARE A HOLDER OF AN EXEMPTION THAT AUTHORIZES THE USE OF A PACKAGING WITH A MAXIMUM CAPACITY LESS THAN 450 L (119 GALLONS) OR A MAXIMUM NET MASS LESS THAN 400 KG (882 POUNDS), PLEASE BE ADVISED THAT YOUR EXEMPTION MAY NOT BE RENEWED BEYOND SEPTEMBER 30, 1996. IN ADDITION, NO NEW CONSTRUCTION OF PACKAGINGS WHICH FALL WITHIN THE NON-BULK CAPACITIES LISTED ABOVE ARE THIS IS CONSISTENT AFTER SEPTEMBER 30, 1994. THE AUTHORIZED REQUIREMENTS ADOPTED UNDER DOCKET IMPLEMENTATION OF THE NEW PACKAGING HM-181. ANY APPLICATION SUBMITTED TO THIS OFFICE TO RENEW AN EXEMPTION BEYOND THE SEPTEMBER 30, 1996 DATE WILL BE DENIED UNLESS THE APPLICATION CONTINUATION OF SUPPORTING INFORMATION TO JUSTIFY THE CONTAINS EXEMPTION.

- 1. Guiberson Division, Dresser Industries, Inc., Dallas, Texas, is hereby granted an exemption from certain provisions of this Department's Hazardous Materials Regulations to offer packages prescribed herein of the hazardous materials described in paragraph 3 below for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes the transportation of jet perforating guns, charged, with devices attached which have been described as detonators by DOT, and provides no relief from any regulation other than as specifically stated.
- 2. <u>BASIS</u>. This exemption is based on Guiberson Division, Dresser Industries, Inc.'s, application dated July 29, 1991, submitted in accordance with 49 CFR 107.103 and the public proceeding thereon.
- 3. <u>HAZARDOUS MATERIALS (Descriptor and class)</u>. Jet perforating guns, charged; guns will be equipped with devices identified as EX-9104082, EX-9104083, EX-9104084, EX-9104085, Class 1.1D, UN0124.
- 4. PROPER SHIPPING NAME (49 CFR 172.101). Jet perforating guns, charged.
- 5. REGULATION AFFECTED. 49 CFR 173.62.
- 6. MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle and cargo vessel.
- 7. SAFETY CONTROL MEASURES. Packaging prescribed is US006.
- 8. SPECIAL PROVISIONS.
 - a. A copy of this exemption must be carried aboard each motor vehicle and cargo vessel used to transport packages covered by this exemption.
 - b. Persons who receive packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with and a current copy of this exemption is maintained at each facility from which such reoffering occurs.

- c. Drivers must have been instructed as to necessary safeguards and proper procedures in the event of unusual delay, fire or accident.
- e. Each package must be prepared and shipped in accordance with 49 CFR 173.62, as applicable for the lading.
- g. Shipments by motor vehicle must be by private carrier.
- 9. <u>REPORTING REQUIREMENTS</u>. Any incident involving loss of packaging contents or packaging failure must be reported to the Associate Administrator for Hazardous Materials Safety as soon as practible. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.)
- 10. EXPIRATION DATE: April 30, 1994.
