IF YOU ARE A HOLDER OF AN EXEMPTION THAT AUTHORIZES THE USE OF A PACKAGING WITH A MAXIMUM CAPACITY LESS THAN 450 L (119 GALLONS) OR A MAXIMUM NET MASS LESS THAN 400 KG (882 POUNDS), PLEASE BE ADVISED THAT YOUR EXEMPTION MAY NOT BE RENEWED BEYOND SEPTEMBER 30, 1996. IN ADDITION, NO NEW CONSTRUCTION OF PACKAGINGS WHICH FALL WITHIN THE NON-BULK CAPACITIES LISTED ABOVE ARE SEPTEMBER <u>30,</u> 1994. THIS IS CONSISTENT WITH THE AFTER IMPLEMENTATION OF THE NEW PACKAGING REQUIREMENTS ADOPTED UNDER DOCKET HM-181. ANY APPLICATION SUBMITTED TO THIS OFFICE TO RENEW AN EXEMPTION BEYOND THE SEPTEMBER 30, 1996 DATE WILL BE DENIED UNLESS THE APPLICATION CONTAINS SUPPORTING INFORMATION TO JUSTIFY THE CONTINUATION OF THE EXEMPTION.

- 1. PPG Industries, Incorporated, Pittsburgh, Pennsylvania, is hereby granted an exemption from certain provisions of this Department's Hazardous Materials Regulations to offer packages prescribed herein containing a nonflammable gas for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes the transportation of DOT Specification 105A500W tank cars which are overdue for tank and safety valve tests to the nearest facility capable of conducting the required tests and provides no relief from any regulations other than as specifically stated.
- 2. <u>BASIS</u>. This exemption is based on PPG Industries Incorporated's applications of July 10, July 14, July 17, and August 3, 1992, submitted in accordance with 49 CFR 107.103, and the public proceeding thereon.
- 3. <u>HAZARDOUS MATERIALS (Descriptor and class)</u>. Chlorine, classed as nonflammable gas.
- 4. PROPER SHIPPING NAME (49 CFR 172.101). Chlorine.
- 5. <u>REGULATION AFFECTED</u>. 49 CFR 173.31(c); 173.29(c)(2).
- 6. MODES OF TRANSPORTATION AUTHORIZED. Rail freight.
- 7. <u>SAFETY CONTROL MEASURES</u>. Packagings prescribed are DOT Specification 105A500W tank cars, meeting all DOT requirements (49 CFR Parts 100-299), except that the tank car tanks and safety valves are overdue for tests.

8. SPECIAL PROVISIONS.

- a. Tank cars must be marked "DOT-E 10845" in four inch letters on a contrasting background above the DOT specification number.
- b. Prior to being offered for transportation, the Associate Administrator for Hazardous Materials Safety must be advised in writing of each tank car shipment, including the tank car number and the intended routing, and the location of each respective repair facility.

c. The Federal Railroad Administration is to be notified if any unusual incident occurs, such as a derailment or tank car damage, during the movement by contacting the:

- d. Persons who receive packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with, and a current copy of this exemption is maintained at each facility from which such reoffering occurs.
- 9. <u>REPORTING REQUIREMENTS</u>. Any incident involving loss of packaging contents or packaging failure must be reported to the Associate Administrator for Hazardous Materials Safety as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.)
- 10. EXPIRATION DATE. September 11, 1993.
