- 1. GRANTEE: Uniroyal Chemical Co., Middlebury CT
- 2. <u>PURPOSE AND LIMITATIONS</u>: Uniroyal Chemical Co., is hereby granted an exemption from certain provisions of this Department's Hazardous Materials Regulations to offer UN certified 4H2 plastic package with a sealed inner plastic bag for the transportation of the materials in paragraph 6 below and provides no relief from any regulation other than as specifically stated.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED:</u> 49 CFR 173.224.
- 5. <u>BASIS</u>. This exemption is based on the Uniroyal Chemical Co., application dated September 8, 1993 submitted in accordance with 49 CFR 107.103 and the public proceeding thereon.

6. <u>HAZARDOUS MATERIALS</u> (49 CFR 172.101):

7. SAFETY CONTROL MEASURES:

- a. <u>PACKAGING</u> Packaging prescribed is a UN 4H2 plastic box with an inner plastic receptacle (sealed, sift-proof, plastic bag).
- b. <u>TESTING</u> Each package as prepared for shipment must be capable of passing PGII drop and stacking tests, and the vibration standard, as found in 49 CFR Part 178 Subpart M.
- c. <u>CAPACITY</u> Each package not to exceed a gross weight of 50 kg (110 lbs.)

d. MARKING - Each package must be permanently and durably marked in accordance with the UN certification marking requirements in Part 178 Subpart L. In addition, each package must be so marked in letters at least one inch on a contrasting background:

DOT-E 11132

The use of labels, tags or signs for marking purposes is prohibited.

8. SPECIAL PROVISIONS.

- a. Persons who receive the packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with and a current copy of this exemption is maintained at each facility from which such reoffering occurs.
- b. Shippers using the packaging covered by this exemption must comply with the shipping paper, marking, labeling, and placarding requirements of 49 CFR Part 172; all provisions of this exemption, and all other applicable requirements contained in 49 CFR Parts 171-180.
- 9. MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle.
- 10. MODAL REQUIREMENTS. No modal specific requirements are required by this exemption.
- 11. <u>COMPLIANCE</u>. Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation laws 49 U.S.C. Section 5101 <u>et seg:</u>
 - o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Registration required by 49 CFR 107.601 <u>et seq.</u>, when applicable.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect unless a regulation has been amended making the exemption no longer necessary. Continuation of DOT-E 11132

12. <u>REPORTING REQUIREMENTS:</u> The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must also inform the AAHMS, in writing, as soon as practicable of any incidents involving the package and shipments made under this exemption.
