- 1. GRANTEE: Regional Hospital Services, Portsmouth, VA
- 2. <u>PURPOSE AND LIMITATION</u>: This exemption authorizes the transportation in commerce of regulated medical waste in the non-DOT specification packaging described in paragraph 7. This exemption provides no relief from any regulation other than as specifically stated herein.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR Part 172.101 Column (8.c) and 173.197 insofar as bulk packagings are prohibited.
- 5. <u>BASIS</u>: This exemption is based on the application of Regional Hospital Services dated April 1, 1994, and supplemental information dated August 23, 1995, submitted in accordance with 49 CFR 107.103 and the public process thereon.
- 6. HAZARDOUS MATERIALS (49 CFR 172.101):

7. PACKAGING AND SAFETY CONTROL MEASURES:

a. <u>PACKAGING</u> - Packaging prescribed is a dual packaging which consists of an outer packaging and an inner packaging as follows:

- i. The outer packaging is a double walled, molded polyethylene bin with a nominal volume of 2330 L (616 gallons). Each bin is a solid, one-piece body of smooth wall injected mold construction, with a hinged and gasketed lid. The exterior surface must be non-porous and easy to decontaminate.
- ii. All regulated medical waste must be double bagged in inner packagings that are securely closed and leak resistant.
- A. Plastic film bags may not exceed a volume of 150 L (40 gallons).
- B. Puncture-resistant sharps containers may not be greater than 38 L (10 gallons) in volume.
- C. Inner packagings for liquids may not exceed 19 L (5 gallons) capacity and must meet the non-bulk packaging standards for Packing Group I for liquids.
- b. <u>TESTING</u> The outer packaging must be capable of meeting the requirements of 49 CFR 178.603 (drop test), as specified for solids at the Packing Group II performance level.

c. OPERATIONAL CONTROLS -

- i. The outer packaging may be reused provided it has an interior surface that is smooth, non-porous and free of cracks or other defects that could obstruct decontamination operations. Prior to being reused, the outer packaging must be decontaminated.
- ii. The outer packagings are authorized for the transportation of regulated medical waste only if such packagings are dedicated exclusively to the transportation of waste materials.
- iii. Waste materials containing small amounts of liquid may be packaged as a solid provided the inner container has sufficient absorbent materials to absorb and retain all liquid during transportation.
- iv. Stacking of outer packagings is prohibited.
- d. MARKING The outside of each outer packaging must be plainly and durably marked "DOT-E 11278".

8. <u>SPECIAL PROVISIONS</u>:

- a. Persons who receive the packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with and a current copy of this exemption is maintained at each facility from which such reoffering occurs.
- b. Shippers using the packaging covered by this exemption must comply with all provisions of this exemption, and all other applicable requirements contained in 49 CFR Parts 171-180.
- c. Prior to transporting a package containing regulated medical waste, the carrier must perform an external visual inspection of each outer packaging to determine that it is properly closed, latched and free of leakage.
- d. The holder of this exemption is responsible for informing the persons responsible for placing waste materials in inner packagings of the limitations on liquids in packaging for solids.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.

10. MODAL REQUIREMENTS:

A copy of this exemption must be carried aboard each motor vehicle used to transport packages covered by this exemption.

- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. Section 5101 <u>et_seq</u>:
 - o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Registration required by 49 CFR 107.601 et seq., when applicable.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect.

12. <u>REPORTING REQUIREMENTS</u>: The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable.

(49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) The holder of this exemption must inform the AAHMS, in writing, of any incidents involving the package and shipments made under the terms of this exemption. Additionally, the holder of this exemption must inform the AAHMS, in writing, of human illness resulting from the handling of regulated medical waste or the unauthorized use of a dedicated vehicle.
