1. GRANTEE: Hach Company, Ames, Iowa
(See Appendix A of this exemption)
2. PURPOSE AND LIMITATION: This exemption authorizes the transportation in commerce of small quantities (30 grams or less) of sodium dithionite (Division 4.2 - PG II) in accordance with 49 CFR Section 173.4. This exemption provides no relief from any regulation other than as specifically stated herein.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR Sections 173.4(a) in that Division 4.2-PG II materials are not authorized.
5. BASIS. This exemption is based on Hach Company's application dated November 2, 1994, submitted in accordance with 49 CFR 107.103 and the public process thereon.
6. HAZARDOUS MATERIALS (49 CFR 172.101):


7. PACKAGING AND SAFETY CONTROL MEASURES: The materials must be packaged in accordance with 173.4(a), in that Division 4.2-PGII materials are not authorized.
- a. QUANTITY LIMITS - The maximum quantity of material per inner receptacle is limited to 30 g (1 ounce).
- ~~b. MARKING - The package does not have to be marked with DOT-E-11359.~~
8. SPECIAL PROVISIONS. Persons who receive the packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with and a current copy of this exemption is maintained at each facility from which such reoffering occurs.
9. MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle, rail freight, cargo only aircraft, and passenger aircraft.
10. MODAL REQUIREMENTS: No Modal-specific requirements are required by this exemption.
11. COMPLIANCE. Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law 49 U.S.C. 5101 et seq:
- o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Registration required by 49 CFR 107.601 et seq., when applicable.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect unless a regulation has been amended making the exemption no longer necessary.

12. REPORTING REQUIREMENTS. The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incidents involving the package and shipments made under the terms of this exemption.


