2. PURPOSE AND LIMITATION:

- This exemption authorizes the transportation in commerce of a Division 4.2 material in DOT Specification 114A340W tank cars equipped with skid protection in place of a protective housing. This exemption provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
- The safety analyses performed in development of this exemption only considered the hazards and risks associated with transportation in commerce.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR §§ 173.31(a); 179.100-1; 179.103-3; and 179.103-4 except as specified herein.

7. PACKAGING(S) and SAFETY CONTROL MEASURES:

- Packaging prescribed are DOT Specification 114A340W tank cars equipped with skids as per the FMC Corporation's drawing SK5-U-7253 in place of the protective housing.
- Each tank car operating under the terms of this exemption must be marked "DOT-E 11473" in four inch letters and numerals on a contrasting background above the DOT specification number.

8. **SPECIAL PROVISIONS:**

- a. A person who is not a holder of this exemption who receives a package covered by this exemption may reoffer it for transportation provided no modification or change is made to the package or its contents and it is reoffered for transportation in conformance with this exemption and the HMR.
- b. A current copy of this exemption must be maintained at each facility where the package is offered or reoffered for transportation.

 - Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by \$\$ 172.700 through 172,704.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect.

12. REPORTING REQUIREMENTS:

The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (Sections 171.15 and 171.16
