- 1. GRANTEE: PPG Industries, Inc., Pittsburgh, Pennsylvania
- 2. <u>PURPOSE AND LIMITATION:</u> This emergency exemption authorizes the transportation, in commerce, of a DOT Specification 105A500W tank car, containing a residual amount of a division 2.3 material, meeting all DOT requirements except that the tank car has a defective safety relief valve which is equipped with a solid cap to prevent emission of chlorine vapors. This exemption provides no relief from any regulations other than as specifically stated.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR 173.29(a), and 179.100-13;
- 5. BASIS. This emergency exemption is based on PPG Industries' application dated June 27, 1995, submitted in accordance with 49 CFR 107.113, and a determination that it is necessary for the protection of life and property.
- 6. HAZARDOUS MATERIALS (49 CFR 172.101):

7. PACKAGING(S) and SAFETY CONTROL MEASURES:

- a. <u>PACKAGING</u> Packaging prescribed is a DOT Specification 105A500W tank car, ACFX 86290, with a defective safety relief valve which has been secured with a solid cap to prevent emission of chlorine vapors.
- b. <u>TESTING</u> The safety relief valve for tank car ACFX 86290 must be retested prior to the tank car being refilled.
- c. <u>MARKING</u> Tank car ACFX 86290 must be marked DOT-E 11495 in four inch letters on a contrasting background above the DOT specification number.

8. <u>SPECIAL PROVISIONS.</u>

- a. Shipment of tank car ACFX 86290 is authorized from Ashdown, Arkansas, to Lake Charles, Louisiana, a distance of approximately 215 miles utilizing the most direct route via the Kansas City Southern Railroad.
- b. Persons who receive packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with, and a current copy of this exemption is maintained at each facility from which such reoffering occurs.
- 9. MODES OF TRANSPORTATION AUTHORIZED. Rail freight.

10. MODAL REQUIREMENTS:

a. The Federal Railroad Administration is to be notified if any unusual incident occurs, such as derailment or exterior tank car damage, during the movement by contacting the:

- 11. <u>COMPLIANCE</u>. Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law 49 U.S.C. Section 5101 <u>et seq</u>:
 - o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Registration required by 49 CFR 107.601 $\underline{\text{et}}$ $\underline{\text{seq.}}$, when applicable.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect unless a regulation has been amended making the exemption no longer necessary. Continuation of DOT-E 11495

12. REPORTING REQUIREMENTS. The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incidents involving the package and shipments made under the terms of this exemption.
