2. PURPOSE AND LIMITATION:

- a. This exemption authorizes the discharge of certain Class 8 liquids from a DOT Specification UN31H2 or UN31HA1 Intermediate Bulk Container (IBC) without removing the IBC from the vehicle on which it is transported. This exemption provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.

- b. The safety analyses performed in development of this exemption only considered the hazards and risks associated with transportation in commerce. The safety analyses did not consider the hazards and risks associated with other uses not associated with transportation in commerce.

3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 177.834(h) in that an IBC is unloaded while on a motor vehicle; and the marking requirements in §§ 172.203(a), and 172.302(c) are waived.
5. BASIS: This exemption is based on the application of Westfalia-Surge, Inc. dated November 24, 2003 submitted in accordance with § 107.109.

7. SAFETY CONTROL MEASURES:

a. PACKAGING - Packaging prescribed are UN31H2 polyethylene IBCs or UN31HA1 composite IBCs having capacities not exceeding 610 gallons, which are securely fastened to the floor of a stake bed vehicle, or secured in a straight box truck or semi-trailer.

b. TESTING - Each IBC must be retested and inspected as specified in § 180.352.

c. OPERATIONAL CONTROLS -

(1) The IBC must be attended by a qualified person at all times during unloading operations. For the purposes of this requirement, "attended" and "qualified" must have the meanings described in § 177.834(i)(3) and (4), respectively.

(2) Hoses may not be attached to discharge outlets during transportation.

(3) IBCs may not be manifolded together.

(4) Two or more materials may not be loaded on the same vehicle if, as a result of any mixture of the materials, an unsafe condition would occur.

8. SPECIAL PROVISIONS:

a. The marking requirements in §§ 172.203(a) and 172.302(c) are waived.

b. A current copy of this exemption must be maintained at each facility where the package is offered or reoffered for transportation.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.

10. MODAL REQUIREMENTS: A current copy of this exemption must be carried aboard each motor vehicle used to transport packages covered by this exemption.

11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:


- o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
- o Persons operating under the terms of this exemption must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
- o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this exemption, including display of its number, when this exemption has expired or is otherwise no longer in effect.

12. REPORTING REQUIREMENTS: The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (Sections 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incident involving the package and shipments made under the terms of this exemption.
