2. PURPOSE AND LIMITATION:

- This emergency exemption authorizes the transportation a. in commerce of a specially designed rail car which has been modified to carry a lighted Olympic Flame system. Fuel for the flame is propane, a Division 2.1 gas, contained in eight (8) non-DOT specification tanks. This exemption provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
- The safety analyses performed in development of this exemption only considered the hazards and risks associated with transportation in commerce.
- REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-3. 180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR Part 171 through 199, except as specified herein.
- 5. BASIS: This emergency exemption is based on the application of Union Pacific Railroad Company dated June 29, 2001, submitted in accordance with § 107.117 and a determination that it is necessary to preclude serious economic loss and supplemental letter dated July 10, 2001.

7. <u>SAFETY CONTROL MEASURES</u>:

- a. <u>PACKAGING</u> Packagings prescribed are eight (8) non-DOT specification 266 gallon capacity tanks constructed to ASME standards that have been fitted into a specially modified rail flat car for the purpose of providing propane fuel to the Olympic Flame cauldron mounted on the rail car.
- b. The rail car must conform to the applicable requirements of 49 CFR Parts 215, 231 and 232.

8. <u>SPECIAL PROVISIONS</u>:

- a. No person may ride on the Olympic Torch Car while it is in motion and the flame is lit.
- b. The car with the flame system must be continuously monitored by personnel in an adjacent coach car whenever the flame is lit.
- c. The emergency response information required by 49 CFR Subpart G and a current copy of this exemption must be carried in the coach car.
- d. Persons who receive the rail car covered by this exemption may transport it provided that no modifications or changes are made to the car, all terms of this exemption are complied with, and a copy of this exemption is maintained by each rail carrier who transports the car.
