1. **GRANTEE:** Compagnie des Containers Reservoirs
Paris, France
(US Agent: ERMEWA, Inc., Houston, TX)

2. **PURPOSE AND LIMITATION:** This exemption authorizes an alternate internal visual inspection schedule for certain DOT Specification IM 101 portable tanks used in dedicated service for the transportation in commerce of chloronitrobenzenes para, solid. This exemption provides no relief from any Hazardous Materials Regulation (HMR) other than as specifically stated herein.
3. **REGULATORY SYSTEM AFFECTED:** 49 CFR Parts 106, 107 and 171-180.
4. **REGULATIONS FROM WHICH EXEMPTED:** 49 CFR § 173.32b(b) in that the inspection interval for the periodic internal inspection is increased to five years.
5. **BASIS:** This exemption is based on the application of ERMEWA, Inc. dated February 22, 2002, submitted in accordance with § 107.105.

6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. SAFETY CONTROL MEASURES:

a. PACKAGING - Packaging prescribed is a DOT Specification IM 101 steel portable tank conforming to § 172.102(c)(7)(i) IM Tank Configuration T14.

b. TESTING -

(1) Each portable tank must be tested and inspected as specified in § 173.32(b) for DOT Specification IM 101 portable tanks except that the internal visual inspection required in § 173.32b(b) may be performed every five years in lieu of every two and one-half years.

(2) Each portable tank must be leak tested prior to each filling.

c. OPERATIONAL CONTROLS - DOT specification IM 101 portable tanks authorized under this exemption may only be used in dedicated service for the transportation in commerce of chloronitrobenzenes para, solid.

8. SPECIAL PROVISIONS:

a. A person who is not a holder of this exemption who receives a package covered by this exemption may reoffer it for transportation provided no modifications or change are made to the package and it is reoffered for transportation in conformance with this exemption and the HMR.

b. a current copy of this exemption must be maintained at each facility where the package is offered or reoffered for transportation.

c. MARKING - Each tank must be plainly and durably marked "DOT-E 12011" as specified in § 172.302(b) and (c).

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle, rail freight and cargo vessel.
10. MODAL REQUIREMENTS: A current copy of this exemption must be carried aboard each cargo vessel or motor vehicle used to transport packages covered by this exemption.
11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:
- o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect.

12. REPORTING REQUIREMENTS: The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (Sections 171.15 and 171.16 apply to any activity undertaken under the authority of this

exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incident involving the package and shipments made under the terms of this exemption.


