1. GRANTEE: Ciba Specialty Chemicals Corporation High Point, NC

2. PURPOSE AND LIMITATION:

- a. This exemption authorizes the transportation in commerce of certain DOT Specification IM-101 steel portable tanks containing a corrosive solid, flammable, material. This exemption provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
- b. The safety analyses performed in development of this exemption only considered the hazards and risks associated with transportation in commerce.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 172.101 Hazardous Materials Table, Column 7 (Special Provisions), in that a DOT Specification IM 101 steel portable tank is not authorized except as specified herein.
- 5. BASIS: This exemption is based on the application of Ciba Specialty Chemicals Corporation dated March 28, 2005, submitted in accordance with § 107.109.

6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. SAFETY CONTROL MEASURES:

- a. PACKAGING Packaging prescribed is a DOT Specification IM 101 stainless steel portable tank which conforms with IM Tank Configuration Code T15 as described in § 172.102(c)(7). Additionally, each tank must have a minimum test pressure of 6 bars, a steam-heating jacket and must be mounted in an ISO frame.
- b. $\underline{\text{TESTING}}$ Each tank must be requalified in accordance with § 173.32b for DOT Specification IM 101 portable tanks.

c. OPERATIONAL CONTROLS -

- (1) After loading, the material authorized by this exemption must be cooled for a sufficient amount of time to ensure that it is a solid prior to transportation in commerce.
- (2) Amyl alcohol may be transported in a tank authorized by this exemption without removing the exemption number from the tank.

8. SPECIAL PROVISIONS:

- a. A person who is not a holder of this exemption who receives a package covered by this exemption may reoffer it for transportation provided no modification or change is made to the package or its contents and it is reoffered for transportation in conformance with this exemption and the HMR.
- b. A current copy of this exemption must be maintained at each facility where the package is offered or reoffered for transportation.

- c. Each portable tank must be marked "DOT-E 12248" on both sides near the middle as specified in §§ 172.302(b) and (c).
- MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle, rail 9. freight and cargo vessel.
- 10. MODAL REQUIREMENTS: A current copy of this exemption must be carried aboard each cargo vessel or motor vehicle used to transport packages covered by this exemption.
- COMPLIANCE: Failure by a person to comply with any of the 11. following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:
 - All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - Persons operating under the terms of this exemption must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
 - Registration required by § 107.601 et seq., when 0 applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by §§ 172.700 through 172,704.

No person may use or apply this exemption, including display of its number, when this exemption has expired or is otherwise no longer in effect.

REPORTING REQUIREMENTS: Shipments or operations conducted 12. under this exemption are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this exemption must notify the Associate Administrator for

Hazardous Materials Safety -- OHMEA, in writing, of any incident involving a package, shipment or operation conducted under terms of this exemption.
