1. <u>GRANTEE:</u> Solutia Inc. St. Louis, Missouri

2. PURPOSE AND LIMITATION:

- a. This exemption authorizes the in-plant use of 28 DOT Specification 111A100W tank cars, containing certain hazardous materials, for in-plant storage and transportation over one railroad crossing-at-grade to the adjoining plant site. This exemption provides no relief from the Hazardous Material Regulations (HMR) other than as specified herein.
- b. The safety analyses performed in development of this exemption only considered the hazards and risks associated with transportation in commerce.
- 3. <u>REGULATORY SYSTEM AFFECTED:</u> 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR \$173.31(b)(6)&(f).
- 5. <u>BASIS.</u> This exemption is based on Solutia Inc's. application dated November 17, 2003, submitted in accordance with § 107.109.

7. SAFETY CONTROL MEASURES:

a. <u>PACKAGINGS</u>: Packagings prescribed are 28 DOT Specification 111A100W tank cars numbered as follows:

b. MARKING: The tank cars must be marked with "DOT E-12269" in accordance with the provisions in \$172.302(c). In addition, the tank cars must be marked in 4-inch letters, "IN-PLANT SERVICE ONLY" or "PLANT SERVICE ONLY".

8. <u>SPECIAL PROVISIONS:</u>

a. The tank cars covered under this exemption are authorized for in-plant storage and transportation between the main plant and the storage track located approximately 600 feet west of the main plant by crossing State Highway 3.

Continuation of DOT-E 12269 (4th Rev.)

- b. Solutia, Inc. must notify the Alton and Southern Railroad and the Terminal Railroad Association of St. Louis that the tank cars covered under this exemption are designated for plant service only.
- c. Solutia, Inc. must arrange with the Association of American Railroads to identify cars in the UMLER system to remove cars from interchange service. The Federal Railroad Administration (FRA) is to be provided with confirmation of this control.
- d. The tank car movement to or from the storage track may not exceed 10 cars in length.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Rail freight.
- 10. <u>MODAL REQUIREMENTS:</u> The FRA is to be notified if any unusual incident occurs during the movement by contacting:

- 11. <u>COMPLIANCE:</u> Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et seq</u>:
 - o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Registration required by § 107.601 <u>et seq.</u>, when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect.

12. REPORTING REQUIREMENTS: The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materi4als Safety (AAHMS) as soon as practicable. (Sections 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incidents involving the package and shipments made under the terms of this exemption.
