2. PURPOSE AND LIMITATION:

- a. This emergency exemption authorizes the transportation in commerce of a small quantity of a Class 8 material (lithium hydroxide) in non-DOT specification packagings. This exemption provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
- b. The safety analyses performed in development of this exemption only considered the hazards and risks associated with transportation in commerce.
- 3. <u>REGULATORY SYSTEM AFFECTED</u>: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 173.212 in that a non-DOT specification packaging is authorized.
- 5. <u>BASIS</u>: This emergency exemption is based on the application of the Department of The Army dated July 27, 2000 submitted in accordance with § 107.117 and a determination that it is necessary for immediate national security.
- 6. HAZARDOUS MATERIALS (49 CFR § 172.101):

- 7. SAFETY CONTROL MEASURES: PACKAGING The inner packaging is a Grade 316 stainless steel cylindrical pressure vessel (identified as a Sorbent Bed Assembly, LS Drawing 5823623H) containing approximately 3.1 pounds of lithium hydroxide, solid. The containment vessel has a burst pressure of 600 psig. The Sorbent Bed Assembly is installed within a larger assembly identified as the Trace Contaminant Control Subassembly (TCCS) Assembly (LMSS Drawing 5823550D). The entire TCCS unit is overpacked in a wooden shipping container.
- 8. <u>SPECIAL PROVISIONS</u>: A person who is not a holder of this exemption who receives a package covered by this exemption may reoffer it for transportation provided no modifications or change are made to the package and it is reoffered for transportation in conformance with this exemption and the HMR.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle
- 10. MODAL REQUIREMENTS: None specified by this exemption
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seg:
 - o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Registration required by § 107.601 <u>et seq.</u>, when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this exemption, including display of its number, when this exemption has expired or is otherwise no longer in effect.

REPORTING REQUIREMENTS: The carrier is required to report 12. any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (Sections 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incident involving the package and shipments made under the terms of this exemption.
