- REGULATIONS FROM WHICH EXEMPTED: 49 CFR \$ 173.12(b)(2)(i) in 4. that a UN 11HH2 composite IBC outer packaging is not authorized except as authorized herein.
- 5. BASIS: This exemption is based on the application of Tri-West Packaging dated May 3, 2001, submitted in accordance with § 107.105 and the public proceeding thereon.

- <u>TESTING</u> In addition to the performance tests required by Subpart O of Part 178, the IBC, loaded to 205 kg and filled to 95% of its' total capacity with a solid material, must be satisfactorily tested in accordance with § 178.603 at the Packing Group II level.
- OPERATIONAL CONTROL As specified in § 173.12(b)(2)(v), the gross weight of the complete package may not exceed 205 kg.

8. SPECIAL PROVISIONS:

- a. In accordance with the provisions of Paragraph (b) of § 173.22a, persons may use the packaging authorized by this exemption for the transportation of the hazardous materials specified in paragraph 6, only in conformance with the terms of this exemption.
- A person who is not a holder of this exemption, but receives a package covered by this exemption, may reoffer it for transportation provided no modifications or changes are made to the package and it is offered for transportation in conformance with this exemption and the HMR. II and the min.

- c. A current copy of this exemption must be maintained at each facility where the package is offered or reoffered for transportation.
- Each packaging manufactured under the authority of this exemption must be either (1) marked with the name of the manufacturer and location (city and state) of the facility at which it is manufactured or (2) marked with a registration symbol designated by the Office of Hazardous Materials Exemptions and Approvals for a specific manufacturing facility.
- e. A current copy of this exemption must be maintained at each facility where the package is manufactured under this exemption. It must be made available to a DOT representative upon request.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.
- 10. MODAL REQUIREMENTS: A current copy of this exemption must be carried aboard each motor vehicle used to transport packages covered by this exemption.
- 11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:
 - All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, Parts 171-180.
 - Registration required by \$ 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this exemption, including display of its number, when this exemption has expired or is otherwise no longer in effect.
