2. PURPOSE AND LIMITATION:

- This emergency exemption authorizes the offering for transportation of a packaging, containing no hazardous material, but represented as containing a hazardous material, for purposes of conducting compliance testing of American Airlines' hazardous materials acceptance and handling procedures. This exemption provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
- The safety analyses performed in development of this exemption only considered the hazards and risks associated with transportation in commerce.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR §§ 172.203(a), 172.301(c), 172.303(a) and 172.401(a)(1) and (2) in that a packaging represented as containing a hazardous material by shipping papers marking and labeling without actually containing a hazardous material is not authorized, except as specified herein.
- 5. This emergency exemption is based on the application of J.J. Keller & Associates dated June 29, 2001, submitted in accordance with § 107.117 and a determination that it is necessary in order to protect life and property.

7. **SAFETY CONTROL MEASURES:**

- a. PACKAGING The packaging consists of a plastic bottle or a fiberboard representation of a bottle, with a capacity of one gallon or less, over packed in a non-specification fiberboard box with cushioning materials. The bottle will be partially filled with sand, water, or may be empty but marked or labeled to indicate that the materials contained in the bottle are those materials listed in paragraph 6 above. Each outer package may or may not be completely marked to reflect a hazardous material shipment.
- b. OPERATIONAL CONTROLS No test packages will contain hazardous materials. All tests will be stopped immediately after acceptance by the carrier or in any case prior to loading aboard an aircraft.
- 8. SPECIAL PROVISIONS: A current copy of this exemption must be maintained at J.J. Keller & Associates, Inc., and be available to a DOT/FAA inspector upon request.
- MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle. Shipments by air will be stopped prior to loading on the aircraft (see paragraph 7b).
- MODAL REQUIREMENTS: No additional requirements other than as 10. required by the HMR.
