1. <u>GRANTEE</u>: U.S. Department of Energy Washington, DC

(See Appendix A to this document for a list of additional grantees)

2. PURPOSE AND LIMITATION:

- a. This exemption authorizes the transportation in commerce for disposal purposes of certain waste hazardous materials, in non-bulk packagings, by private vehicle for short distances in a specially designed bomb-disposal trailer as the outer packaging. This exemption provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
- b. The safety analyses performed in development of this exemption only considered the hazards and risks associated with transportation in commerce.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR Subparts C, E (except for Division 4.2 spontaneously combustible materials) and F of Part 173 (except for Type B radioactive materials) in that a specially designed bomb-disposal trailer may be substituted for any DOT Specification or non-DOT specification outer packaging authorized for the transport of hazardous materials in the HMR.
- 5. <u>BASIS</u>: This exemption is based on the application of U.S. Department of Energy (USDOE) dated August 20, 2003, submitted in accordance with § 107.109.

6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. <u>SAFETY CONTROL MEASURES</u>:

a. <u>PACKAGING</u> - Packaging prescribed is non-DOT specification triple packaging system described as follows:

Inner Packaging: Receptacles, glass, metal, plastic,

with securely sealed closures, sufficiently cushioned to prevent any movement during transport.

Intermediate Packaging: Boxes or drums (fiberboard, metal

or plastic).

Outer Packaging: Non-specification, specially

designed bomb disposal trailer and lid (Hurd Bomb Trailer Model 300) built according to the drawings and specifications included in the exemption application on file with the Office of Hazardous Materials

Exemptions and Approvals.

b. OPERATIONAL CONTROLS -

- (1) The outer packaging may not be filled to more than 90% of its volumetric capacity with the waste materials identified in paragraph 6 above per shipment.
- (2) Transportation is only authorized by private carriage from the USDOE Oak Ridge Reservation to a treatment or disposal facility destination within a 35 air mile radius of the USDOE Oak Ridge Reservation.

- (3) When transporting suspected or known thermally unstable materials, the Self Accelerating Decomposition Temperature (SADT) shall first be determined on each substance and sufficient refrigeration shall be provided during transport to maintain the temperature of these materials to at least 20°C below their SADT during the transport, including the interval from first loading of the bomb-disposal trailer to its unloading at the disposal facility.
- 8. <u>SPECIAL PROVISIONS</u>: A current copy of this exemption must be maintained at each facility where the package is offered for transportation.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.

10. MODAL REQUIREMENTS:

- a. A current copy of this exemption must be carried aboard each motor vehicle used to transport packages covered by this exemption.
- b. The bomb-disposal trailer (outer packaging) must be plainly and durably marked "DOT-E 12827" as specified in \$\$ 172.302(b) and (c).
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et seq</u>:
 - o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Registration required by § 107.601 et seg., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this exemption, including display of its number, when this exemption has expired or is otherwise no longer in effect. 12. REPORTING REQUIREMENTS: The carrier is required to report any incident involving explosion, fire or loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (Sections 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incident involving the package and shipments made under the terms of this exemption.
