1. <u>GRANTEE</u>: ChevronTexaco Richmond, CA

# 2. <u>PURPOSE AND LIMITATION</u>:

- a. This emergency exemption authorizes the one-time, one-way transportation in commerce of a pyrophoric solid in a non-DOT specification cylinder. This exemption provides no relief from any regulation other than as specifically stated herein.
- b. The safety analyses performed in development of this exemption only considered the hazards and risks associated with transportation in commerce. The safety analyses did not consider the hazards and risks associated with consumer use, use as a component of a transport vehicle or other device, or other uses not associated with transportation in commerce.
- 3. <u>REGULATORY SYSTEM AFFECTED</u>: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 173.187 in that a non-DOT specification cylinder is not an authorized packaging except as specified herein; the marking requirement in § 172.301(c).
- 5. <u>BASIS</u>: This emergency exemption is based on the application of ChevronTexaco dated January 23, 2003 and supplemental information dated January 24, 2003, submitted in accordance with § 107.117 and a determination that it is necessary to prevent significant economic loss.

## 6. HAZARDOUS MATERIALS (49 CFR § 172.101):

#### 7. SAFETY CONTROL MEASURES:

a. <u>PACKAGING</u> - Packaging prescribed is a non-DOT specification cylinder manufactured by Dynetek Industries Ltd. The cylinder is manufactured to the NGV2 standard and has a maximum allowable working pressure of 4,500 psig and a maximum operating pressure of 3,600 psig. The cylinder must be attached to a wooden frame and secured within a metal drum. The drum must be banded to a wooden pallet.

# b. OPERATIONAL CONTROLS -

- (1) Prior to transportation, the cylinder must be padded with helium. The pad pressure must not exceed 15 psig.
- (2) Transportation is only authorized between the ChevronTexaco facility in Richmond, CA and Quantum Technologies in Irvine, CA.
- (3) Transportation must be in a truck drived by ECD Ovonics Inc. employees.

### 8. <u>SPECIAL PROVISIONS</u>:

- a. A person who is not a holder of this exemption who receives a package covered by this exemption may reoffer it for transportation provided no modifications or changes are made to the package and it is reoffered for transportation in conformance with this exemption and the HMR.
- b. A current copy of this exemption must be maintained at each facility where the package is offered or reoffered for transportation.

- c.  $\underline{MARKING}$  The marking specified in § 172.301(c) is waived.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.
- 10. <u>MODAL REQUIREMENTS</u>: A current copy of this exemption must be carried aboard each motor vehicle used to transport packages covered by this exemption.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et seq</u>:
  - o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
  - o Registration required by § 107.601 <u>et seq.</u>, when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this exemption, including display of its number, when this exemption has expired or is otherwise no longer in effect. Continuation of DOT-E 13197

12. REPORTING REQUIREMENTS: The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (Sections 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incident involving the package and shipments made under the terms of this exemption.
