1. <u>GRANTEE:</u> Alaska Pollution Control Anchorage, AK

2. PURPOSE AND LIMITATION:

- a. This emergency exemption authorizes the transportation in commerce of xanthates in 55-gallon drums which exceed quantities authorized for transportation by cargo aircraft only. This exemption provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
- b. The safety analyses performed in development of this exemption only considered the hazards and risks associated with transportation in commerce.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED:</u> 49 CFR Table §§ 172.101, Column (9B) in that the quantity limitation for cargo aircraft is exceeded and 172.301(c) in that the marking requirement is waived.
- 5. <u>BASIS:</u> This emergency exemption is based on Alaska Pollution Control's application dated September 24, 2003 submitted in accordance with § 107.117 and a determination that it is necessary to prevent significant economic loss.

7. <u>SAFETY CONTROL MEASURES</u>:

- a. PACKAGING Packaging prescribed is as authorized by 49 CFR 173.213.
- b. <u>OPERATIONAL CONTROLS</u> Transportation by cargo aircraft only is authorized from the Nixon Fork Mine which is located approximately 40 air miles from McGrath, AK to Anchorage International airport.
- 8. <u>SPECIAL PROVISIONS</u>: A current copy of this exemption must be maintained at each facility where the package is offered or reoffered for transportation.
- 9. MODES OF TRANSPORTATION AUTHORIZED. Carqo aircraft only.
- 10. <u>MODAL REQUIREMENTS:</u> A current copy of this exemption must be carried aboard each aircraft used to transport hazardous materials covered by this exemption.
- 11. <u>COMPLIANCE</u>. Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5105 <u>et seq:</u>
 - o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8 who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in

addition to the training required by § 172.700 through § 172.704.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect.

12. REPORTING REQUIREMENTS. The holder of this exemption is required to report any incident involving fire, explosion or loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (Sections 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incident involving the package and shipments made under the terms of this exemption.
