Pedestrian	3	Code 3 is used for a participant who is not an occupant of a motor vehicle in transport, a parked vehicle, a pedalcycle, or other type of transport vehicle; and is not in the act of towing another person or object. For a pedestrian who is being towed, use Participant Type code 3, and Participant Level Event Code 008. Code 3 is the appropriate code to use for a pedestrian who is carrying another person, such as a child; and for the person being carried. Pedestrian using a pedestrian conveyance (wheelchair, skates, etc.)	4	Code 4 is used for a pedestrian who is on a conveyance, such as a wheelchair (including motorized wheelchairs), skates, skateboard, etc. For a participant using a non-motorized wheelchair, enter code 106 in the Participant Level Event field. Pedalcyclist	6	Code 6 is used for an occupant of a non-motorized pedalcycle in transport, who is not in the act of towing another person or object. For a person riding as a passenger on a pedalcycle, use Participant Type code 6, and Participant Level Event code 105.
