Mission Statement

To reduce the number and severity of traffic crashes in Indian Country by supporting Education, Enforcement, and safe tribal community programs.

Vision Statement

To create a safe tribal community environment where roadways in Indian Country are safe for all.

Introduction

According to the 2010 U.S. Census, the United States is home to 308,745,538 people. Of these individuals, approximately 2,932,248, 0.9%, identify themselves as American Indian and/or Alaska Native. Consistent with the general population in the United States, the largest age group for American Indian/Alaska Natives is 35-44 years of age. These American Indians/Alaska Natives represent over 560 federally recognized Tribes throughout the country.

Despite their small ethnicity numbers, American Indians/Alaska Natives continue to be killed and injured in traffic crashes at rates that are 2 to 3 times that of other ethnic groups and that of the national average.

Because the Tribes that comprise the Indian Nation are geographically spread throughout the United States, it is extremely difficult to affect change in motor vehicle deaths in each of them. Each Tribe is unique in its heritage, language and lifestyle. The lack of motor vehicle crash data and Tribal reporting are areas of continual struggle.

The FY14 Request for Proposal (RFP) was mailed to the Tribal Leaders of all federally recognized Tribes in the United States in February 2013. Prospective applicants were required to submit proposals no later than May 1, 2013. The Indian Highway Safety Program (IHSP) received 42 tribal project proposals for FY14.

A Selection Committee met in May of 2013 to review and score all proposals. This Selection Committee was comprised of representatives from the National Highway Traffic Safety Administration, Bureau of Indian Affairs Indian Highway Safety Program, Indian Health Service, Office of Justice Services, and a representative from the New Mexico Highway Safety Office. 31 Tribal highway safety projects were included in the FY14 Highway Safety Plan submitted to NHTSA for final approval. NHTSA approved 31 Projects for funding.

The approved IHSP projects for FY14 consisted of 31 enforcement grants, for Tribes in 12 different states, in the program areas of Police Traffic Services and Overtime enforcement. The IHSP also issued one grant award for an Impaired Driving Court grant. These Tribes included some of the largest Tribes in the country. Data provided in this report is based upon statistics submitted from 31 Tribal projects and the national Fatality Analysis Reporting System.

The IHSP staffing for FY14 included a Program Director, Program Coordinator, Financial Analyst, Law Enforcement Liaison, and two (2) Law Enforcement Assistants.

FY14 Tribal Project Reports

In FY14, the IHSP staff was tasked with managing 31 Tribal projects throughout the year. Each month, the Tribal projects were required to submit a narrative report on the progress of their individual Performance Measures/Targets as well as a Request for Reimbursement.


The IHSP expended a total of **\$3,272,688.69** in FY14 for Tribal Highway Safety Projects, BAT Mobile operation and maintenance costs, and Planning and Administration.

IHSP Targets for FY14


Overall Program Target:

To reduce death and injury rates resulting from traffic crashes among Indian Tribes and on the reservations within the United States.

To reduce the number of fatalities on reservations in Indian Country by 10% from the 2010 FARS number of 102 to 92 by the end of FY14. On reservation deaths were 201 in 2011.



According to the FARS numbers, MVC fatalities (total number of deaths) among American Indians/Alaska Natives decreased significantly from **438** in 2010 to **569** in 2011. MVC fatalities "On Indian Reservation" for 2010, declined from 128 in 2010 to 207 in 2011.



In FY14: 31 Tribes reported a total of **61** motor vehicle crash (MVC) fatalities on their reservations. **28 (46%)** involved alcohol, **20** (33%) involved excessive speed and **37 (61%)** of the people killed were not wearing seat belts.

These 3 Tribes accounted for **38%** of the total of **61** fatal MVCs reported to the BIA IHSP.

In FY13: 34 Tribes reported a total of **80** motor vehicle crash (MVC) fatalities on their reservations. **47 (58.75%)** involved alcohol, **33 (41.25%)** involved excessive speed and **47 (58.75%)** of the people killed were not wearing seat belts.


These 3 Tribes accounted for 31% of the total of 80 fatal MVCs reported to the BIA IHSP.


In FY12: There were 63 reported MVC fatalities from the 26 Tribes funded by IHSP.

These 3 Tribes alone accounted for 36% of the 68 motor vehicle crash fatalities.





In FY14: The 31 funded Tribes reported a total of **4,295** motor vehicle crashes, of which **912 (21%)** were injury crashes. **573** of the crashes involved alcohol and **542** were speed involved.

In FY13: The 34 funded Tribes reported a total of **4,012** motor vehicle crashes, of which **945 (23.53%)** were injury crashes. **531** of the crashes involved alcohol and **285** were speed involved.

In FY12: The 26 funded Tribes reported a total of **3,012** motor vehicle crashes, of which **709 (23.54%)** were injury crashes.

Planning & Administration:

The Target of the BIA IHSP is to effectively administer highway safety funds, offer technical assistance to all Tribes requesting assistance and monitor funded projects to reduce traffic related deaths and injuries in Indian Country.

The BIA IHSP awarded 31 project grants in FY14. During the fiscal year, services and technical assistance were provided to approximately 50 Tribes throughout the country. This was accomplished by providing media materials for the impaired driving and safety belt mobilizations. Tribes not currently funded by the IHSP also attend Lifesavers Conference and Grant Writing training.

Impaired Driving:

The BIA IHSP planned to reduce the incidence of impaired driving by increasing sustained DUI/DWI/OWI arrests by all funded traffic activity within the participating Tribes by 10% from the FY12 total of 4,056 to 4,462 by the end of FY14.

30 tribes were funded for traffic enforcement grants and 1 OWI Court grant in FY14 34 tribes were funded for traffic enforcement grants and 1 OWI Court Grant in FY13 26 tribes were funded for traffic enforcement grants in FY12

In FY 14: 31 Tribes funded reported **5,112** DUI/DWI/OWI arrests. This Target was substantially exceeded.

In FY14: 31 funded Tribes reported a total of **20** fatalities with drivers with .08+ BAC.

In FY14: 31 funded Tribes reported a total of 28 fatalities that were alcohol related

In FY13: 34 funded Tribes reported a total of **30** fatalities with drivers with .08+ BAC.


In FY13: 34 funded Tribes reported a total of 47 fatalities that were alcohol related.

In FY12: 26 funded Tribes reported a total of **26** fatalities with drivers with .08+ BAC.

In FY12: 26 funded Tribes reported a total of 40 fatalities that were alcohol related.

Occupant Protection:

The BIA IHSP planned to increase safety belt usage rates in Indian Country from the "National" Indian Country rate of 68.8% to 71% by the end of FY14.



Safety Belt usage has increased from 69.60% in FY13 to 73% in FY14.

The BIA IHSP planned to incrase the number of Tribes participating in Click It or Ticket national mobilization from 40 to 50 by the end of FY14.

29 Tribal and BIA police agencies signed up to participate in the **Click It or Ticket** national safety belt mobilization and reported statistics on activity reports.

Performance Measure to be tracked: Number of seat belt citations issued during grant-funded enforcement activities.

In FY14: The 31 Tribes funded by the BIA IHSP reported issuing a total of **3,783** safety belt violations and **744** child passenger safety violation citations throughout the project year.

In FY13: The 34 Tribes funded by the BIA IHSP reported issuing a total of **5,166** safety belt violations and **907** child passenger safety violation citations throughout the project year.

In FY12: The 26 Tribes funded by the BIA IHSP reported issuing a total of **3,173** safety belt violations and **696** child passenger safety violation citations throughout the project year.

Police Traffic Services:

The BIA IHSP planned to reduce the number of speed related fatalities on Indian Reservations by 24% from the FY2010 FARS numbers of 41 to 31 by the end of FY14. The most current FARS data from 2011 showed there was an increase to 76 in 2011. Speed related fatalities appear to be trending down in the funded Tribes. The Police Traffic Services grants are designed to provide an ongoing sustained impaired driving, occupant protection and child passenger safety enforcement throughout the grant year.

In FY14: The 31 Tribes funded by the BIA IHSP reported a total of **20** speed-related motor vehicle fatalities on their reservations during the project year.

In FY13: The 34Tribes funded by the BIA IHSP reported a total of **33** speed-related motor vehicle fatalities on their reservations during the project year.

In FY12: The 26 Tribes funded by the BIA IHSP reported a total of **14** speed-related motor vehicle fatalities on their reservations during the project year.

The BIA IHSP planned to increase the number of citations issued for speed by 5% from the FY12 total of 13,641 to 14,323 within the participating Tribes by the end of FY14.

In FY14: 31 Tribes funded by the BIA IHSP reported **30,613** speed citations being issued during the project year. This more than doubled the project amount.

The BIA IHSP planned to increase the number of citations issued for other moving violations (excluding speed and DUI) by all funded traffic activity by 5% from the FY12 total of 22,406 to 23,526 by the end of FY14.

In FY14: 31 Tribes funded by the BIA IHSP in FY14 reported **34,861** traffic violation citations, substantially exceeding the target.

In FY12: Number of pedestrian fatalities reported by 26 Tribes in FY12 was 7.

Traffic Records:

Target:

To provide resources, training and technical assistance to Tribes in an effort to estabilish traffic records systems on Indian Reservations.

Performance Measure:

To convene quarterly meetings of the Tribal Traffic Records Coordinating Committee.

In FY14 the Tribal Traffic Records Coordinating Committee was not established. Quarterly meetings, travel and training did not take place. .

Summary:

The IHSP contacted the Tribal Traffic Records Coordinating Committee proposed members and a planning teleconference was held on October 2, 2014. Follow up meetings will be held in December 2014 with other federal partners in order to identify the needs of our tribal partner.

IHSP leadership will identify and discuss potential avenues to expend the Section 408 funding in the near future.

The IHSP is also currently evaluating potential training sites to present traffic records training to the tribes. This is currently in the planning phase.

Impaired Driving Program Area

The BIA Indian Highway Safety Program has over the years funded many projects aimed at reducing the high rates of drinking and driving on the reservations. The program also remains committed to providing training, educational materials and equipment necessary to assist tribal law enforcement officers and police departments in their efforts to remove drunk drivers from the roadways through sustained enforcement efforts.

All funded projects in FY14 signed a commitment to participate in all national traffic safety campaigns. Tribes were also required to participate in, and report on, the "Don't Shatter the Dream", Indian State Impaired Driving Mobilization. Funded Tribes participated by conducting checkpoints, saturation patrols and/or enhanced enforcement. Extra funding was added to each project budget for high visibility sustained enforcement throughout the year.

Each of the tribal projects funded in FY14 had an alcohol related performance measure.

Impaired Driving Program Area Target:

The BIA IHSP planned to reduce the incidence of impaired driving crashes by increasing DUI arrests within the participating Tribes by 10% from the FY12 total of 4,056 to 4,462 by the end of FY14.

In FY14: 29 Tribes funded by the BIA IHSP in reported **5,112** DUI/DWI/OWI arrests.

In FY14: 17 Tribes reported conducting 175 checkpoints.

In FY14: 27 Tribes reported conducting 1,230 saturation patrols.

In FY13: 34 Tribes funded by the BIA IHSP in reported **5,145** DUI/DWI/OWI arrests.

In FY13: 34 Tribes reported conducting 224 checkpoints.

In FY13: 26 Tribes reported conducting **1,316** saturation patrols.

In FY12: 26 Tribes funded by the BIA IHSP in reported **4,056** DUI/DWI/OWI arrests.

In FY12: 26 Tribes reported conducting 213 checkpoints.

In FY12: 26 Tribes reported conducting **1,610** saturation patrols.

The White Earth, Leech Lake, and Upper Sioux Tribes in Minnesota and the Shoshone-Bannock Tribe in Idaho could not conduct sobriety checkpoints as state law does not permit but did participate in the saturation patrols.

For each Tribal project, the Reservation Population and Land Base information is from Tiller's Guide to Indian Country updated with 2010 Census data with the exception of the Ramah-Navajo and Upper Sioux Tribes.

Grant Award: \$100,000.00 **Amount Expended:** \$28,607.95

Target:

To provide support for the continued operation and maintenance of the Breath Alcohol Testing (BAT) Mobiles purchased for use in Indian Country which will result in decreased alcohol related motor vehicle crash injuries and fatalities within the participating Tribes.

PERFORMANCE MEASURES:

To increase the number of times the BAT Mobiles are deployed within the participating Tribes by 15% from the FY12 total of 103 to 118 by the end of FY14.

In FY14 the BAT Mobile was deployed 62 times. Of the 62 deployments 21 were from participating tribes.

To increase use of BAT Mobiles for educational events on the reservations in FY14. Baseline will be set in FY13.

In FY14 the BAT Mobiles were not used for 6 educational events.

To increase use of BAT Mobiles at checkpoints on the reservations in FY14.

In FY14 the BAT Mobiles were used in 62 check points.

To support the Tribes in BIA OJS Districts I (South Dakota), II (Oklahoma), IV (Albuquerque) and V (Billings) by providing resources to utilize the BAT Mobiles.

The BIA IHSP purchased four (4) BAT Mobiles for Tribal use in FY10. It was a collaborative effort between the BIA IHSP and BIA OJS District II (Muscogee, OK), OJS District IV (Albuquerque, NM) and District V (Billings, MT – 2 BAT Mobiles).

At the beginning of FY13, one of the BAT Mobiles from District V-Billings was moved to OJS District I (Aberdeen, SD). This allowed for a total of approximately eighty (80) Tribes to have access to the BAT Mobiles in these four OJS Districts.

The purchase of these BAT Mobiles has allowed Tribes to more effectively combat drunk drivers on the reservations and to decrease alcohol related motor vehicle crash injuries and fatalities within the participating tribes in OJS Districts I, II, IV and V.

The BAT Mobiles were utilized in the four BIA OJS Districts at sobriety checkpoints and were made available for viewing to Tribal community members and school students during health fairs and public safety days.

The BAT Mobiles in Districts I and IV were out of service because of mechanical issues for part of the project year. This is felt to be due to the age of the BAT Mobiles.

This project was funded to establish and maintain a DWI Court Team responsible for the implementation of a DWI Court on the Lower Brule Sioux reservation

PERFORMANCE MEASURES/TARGETS:

1. To reduce the number of motor vehicle related crashes, injuries and deaths on the Lower Brule Reservation from the FY2012 number of 2, to 1, by the end of FY2014.

No data on reductions of crashes, injuries and deaths

2. By the end of FY2014, establish a DWI dedicated court.

DUI Court was established

Final Report on Performance Measures/Targets:

An OWI Probation Officer was not hired in the first quarter. The Lower Brule Sioux Tribal Court did not have the physical capacity to bring on another probation officer dedicated solely to the DUI court. The Tribal Court currently has 4 probation Officers who assist one another with probationer check ins, urinalysis and SCRAM bracelet downloads.

The Lower Brule Sioux Tribe established and maintained Operating While Intoxicated (OWI) Tribal Court on the Lower Brule Reservation. The DUI court team consists of the judge, prosecutor, public defender, probation clerk, community/elder and substance abuse professionals. DUI court is every Thursday afternoon; the team staffs each case prior to hearing. Evaluate OWI offenders to determine the number of offenders to be placed into the OWI court program. The Lower Brule Impaired Driving Court accepted its first case in February 2014. There are now 5 Cases in DUI court (3 women, 2 men).

DUI Court Team Members and Synthetic Drug Task Force organized a community Walk and education event in July. They also organized a tribal staff event and community education event in September 2014. Driving while impaired whether by alcohol or synthetic drug use, is a major concern to the community.

An Impaired Driving Court manual and forms was developed to implement the DUI Court along with policies and procedures which incorporate *The Guiding Principles of DWI Courts*.

A resolution supporting establishment and operation of the DUI court is pending before the Tribal Council.


This Tribe was funded for the DWI Court in FY15.

Occupant Protection Program Area

Motor vehicle crashes are the leading cause of death and injuries to Native Americans in the United States. Native Americans are killed at rates at least twice that of all other ethnic groups in this country. These high death rates can be attributed to a number of factors including the low and non-use of safety belts and child passenger safety restraint usage on the reservations.

Occupant Protection Program Area Target:

The BIA IHSP planned to increase safety belt usage rates in Indian Country from the FY 12 "National" Indian Country rate of 68.8% to 71% by the end of FY14.



Indian Country is now at **73.4% in 2014**. While Native American utilization is still lower than the national rate, there has been progress made in Indian Country.

Child Passenger Safety

For several years, the BIA IHSP has collaborated with the Indian Health Service to provide child passenger safety seats for Native American children and child passenger safety support safety materials for clinics, checkpoints and fitting stations for those Tribes working with their respective Indian Health Service Injury Prevention Specialists.

In FY14, the BIA IHSP did not awarded Child Passenger Safety grants to the Tribes. The BIA IHSP expended a total of **\$0.00** on child safety seats in FY14. This program currently being re-evaluated and formatted for accountability within BIA IHSP and with the grantees for FY15.

Police Traffic Services Program Area

The BIA Indian Highway Safety Program has remained committed to providing the necessary tools and training that Tribal law enforcement departments need in order to effectively enforce traffic laws and ordinances.

All Tribal law enforcement agencies funded in FY14 signed commitments to participate in all national mobilizations as well as enhanced enforcement at other times of the year and sustained enforcement throughout the year. Additionally, extra funding was added to each project so they could conduct high visibility enforcement throughout the year.

The BIA IHSP staff depends on the NHTSA Region 6 Media Consultant to provide Public Information & Education information so information may be distributed to Tribes nationwide. It is invaluable during the national mobilizations the Tribes are required to participate in. Unfortunately, these services were not available in 2014.

The LEL also worked on specific task orders and was responsible for outreach, to include at least 50% travel time, to a designated number of Tribes during 2014 (PG 57 HSP)

A majority of the LEL's time was spent on site visits. Site visits included eight (8) current project Tribes; four (4)Montana (Rocky Boy, Crow, Northern Cheyenne, Blackfeet); one (1) in Wyoming (Eastern Shoshone; and three (3) tribes in Minnesota (Red Lake, Leech Lake, White Earth).

The BIA IHSP Director assisted the LEL with conducting site visits to one (1) tribe in New Mexico (Santa Ana), four (4) tribes in South Dakota (Rosebud, Oglala, Sisseton; Lower Brule) and three (3) tribes in Minnesota, (Red Lake, Leech Lake, White Earth)

The site visits were used to ensure compliance with grant agreement requirements and evaluate the project progress toward stated goals.

In FY15, the LEL will continue to evaluate and assist Tribes to meet their performance measures/targets.

Police Traffic Services (PTS) Program Area Target:

To reduce the number of speed related fatalities on Indian Reservations by 24% from the 2010 FARS numbers of 41 to 31 by the end of FY14.

To reduce the on reservation speeding related fatalities from 41 to 35 in 2014.

The 31 Tribes funded by the BIA IHSP in FY14 reported a total of **20** speed-related motor vehicle fatalities on their reservations during the project year. This Target was met.

To increase the number of citations issued for speed by full-time funded Highway Safety Officers by 5% from the FY12 number of 13,641 to 14,323 by the end of FY14.

31 Tribes funded by the BIA IHSP in FY14 reported **30,613** speed citations being issued during the project year. This Target was substantially exceeded.

To increase the number of citations issued for other moving violations (excluding speed and DUI) by full-time funded Highway Safety Officers funded traffic activity by 5% from the FY12 total of 22,406 to 23,526 by the end of FY14.

31 Tribes funded by the BIA IHSP in FY14 reported **34,861** traffic violation citations. This Target was substantially exceeded.

To decrease the number of AI/AN motorcyclist fatalities by 11% from the 2010 FARS number of 35 to 31 by the end of FY14.

Number of motorcyclist fatalities reported by the 31 funded Tribes was **3.** Number of un-helmeted motorcyclists was **3.**

To decrease the number of AI/AN pedestrian fatalities by 5% from the 2010 FARS number of 64 to 61 by the end of FY14.

Number of pedestrian fatalities reported by 31 Tribes in FY14 was 11.

The most current FARS data from 2011 showed the number of fatalities on reservations increased to 207 in 2011. Fatalities appear to be trending down in the funded Tribes.

In FY14: 31 Tribes reported a total of 61 motor vehicle fatalities.

C-4 Core Measure: To reduce the number of passenger vehicle occupants on reservations by 10% from 101 in 2010 to 92 in 2014. The most current FARS data from 2011 shows there was an increase to 135. Fatalities appear to be trending down in the funded Tribes.

In FY14: 31 Tribes reported a total of 61 motor vehicle crash (MVC) fatalities on their reservations. Of the 61 motor vehicle fatalities 37 (61%) of the people killed were not wearing seat belts.

C-5 Core Measure: To decrease the number of fatalities in crashes involving a driver/motorcycle rider, on reservation, with a BAC of 0.08 and above from 61 in 2010 to 55 in 2014. The most current FARS data from 2011 showed the number of fatalities in crashes involving a driver/motorcycle rider increased to 104 in 2011. Motorcycle related fatalities appear to be trending down in the funded Tribes.

In FY14: 31 funded Tribes reported a total of 20 fatalities with drivers with .08+ BAC.

C-6 Core Measure: To reduce the number of speed related fatalities on Indian Reservations by 24% from the 2010 FARS numbers of 41 to 31 by the end of FY14. The most current FARS data from 2011 shows there was an increase to 76 speed related fatalities appears to be trending downward in the funded tribes.

The 31 Tribes funded by the BIA IHSP in FY14 reported a total of 20 speed-related motor vehicle fatalities on their reservations during the project year.

C-7 Core Measure: To reduce the on reservation motorcyclist fatalities from 6 in 2010 to 5 in 2014. The most current FARS data from 2011 showed that there was a decrease to 2 in 2011.

MOBILIZATION AND MEDIA ACTIVITY

In FY 14 the BIA IHSP reimbursed funded projects for media activity expenses totaling \$20,415.97. This included billboard rentals, radio, and other media outlets. Posters and flyers were displaced in communities, schools, and bus stops. Newsletters and email sent out to tribal community and staff. Highway signs were also posted.

LOOKING TO THE FUTURE

Overall, FY14 was a challenging and successful year for the Tribes funded by the Indian Highway Safety Program. We will continue to be dedicated to working closely with the Tribes and strive to remain in close partnership with all our traffic safety partners.

2014 has disclosed several issues that will be reviewed and addressed in 2015. They include:

- Improved project monthly and annual reporting
- Evaluation of office productivity
- Improving data collection and reporting
- Increasing utilization and reporting of Bat Mobiles
- Expanding the IHSP outreach to youth

Motor vehicle crash fatalities significantly decreased within the projects funded by IHSP from FY13 to FY14. Alcohol involved and non-seat belt use in the fatal crashes was 30%. Increased efforts in these areas will be made in FY16.

Participating tribal law enforcement programs worked overtime with fulltime and overtime projects work aggressively to enforce traffic safety and impaired driving laws in FY14. The Highway Safety Officers funded under this grant often work in difficult political, economic and physical environments and we will continue to support their efforts.

The IHSP plans to continue to work toward meeting and surpassing the Performance Measures/Targets outlined in our FY15 Highway Safety Plan. With fully staffed IHSP personnel in FY14, we are well prepared to meet the targets and challenges in the coming year.

The IHSP will renew its efforts in FY15 to improve the collection of traffic data and to make it the cornerstone of the highway safety program. Sharing of traffic statistics among all stakeholders will enable all of everyone to improve performance and save lives. Although Police Traffic Services and enforcement is the main focus, we would also like to focus more on behavior change. In FY15 the IHSP will be relaunching Child Passenger Safety grants to fund the tribes.
