



## **AASHTO and FHWA Announce Round 5 Recipients of SHRP2 Implementation Assistance Program**

Today AASHTO and FHWA are pleased to announce 21 transportation organizations as recipients of the Round 5 Implementation Assistance Program (IAP). Four SHRP2 solutions were featured in Round 5, and with these selections, work will begin on 27 projects in 20 States and the District of Columbia.

Round 5 assistance opportunities were available at the proof of concept pilot, lead adopter incentive, and user incentive levels. Recipients for Round 5 represent varied geographic locations throughout the Nation. Attached to this email is the full list of selections for Round 5, along with an announcement of anticipated products coming in Rounds 6 and 7.

### **IAP Rounds 6 and 7**

Looking to the future, we are planning two more rounds of the IAP. We strongly encourage transportation agencies to review the attached listing of anticipated SHRP2 products, and to take advantage of these opportunities for implementation and technical assistance available through the IAP. The Round 6 application period begins May 29 and closes June 26, 2015. Registration for Round 6 Webinars will open mid-April on the [GoSHRP2 Web site](#).

Information on the schedule for Round 7 will come in the next few months. No full scale or formal IAP opportunities are planned beyond round 7, so we urge you to take advantage of these final opportunities offered in Rounds 6 and 7. After the IAP concludes, there may be some limited opportunities to provide assistance on a case-by-case basis to agencies wishing to implement SHRP2 products, as our funding permits.

### **SHRP2 Education Connection**

Earlier this year, we also launched a new initiative called SHRP2 Education Connection. This opportunity is designed to introduce SHRP2's proven innovations and technologies to the next generation of transportation professionals. The FHWA will award up to 10 cooperative agreements for universities and colleges to incorporate SHRP2 Solutions into transportation coursework, bringing SHRP2 products into the classroom.
