Dear Secretary LaHood:

Pursuant to Title XII, Section 1201 of the American Recovery and Reinvestment Act (Pub. L. 111-5 (Feb. 17, 2009)) ("ARRA"), I certify that the State of North Carolina will maintain its efforts regarding State funding for the types of projects in the United States Department of Transportation (DOT) "covered programs" funded under ARRA.

In accordance with Section 1201 Maintenance of Effort clarifying guidance, planned state expenditures for Highway Infrastructure Investment have been amended to include state funding to local governments. The revised enclosed list of DOT "covered programs" identifies the amount of funds the State plans to expend from State sources from February 17, 2009 to September 30, 2010, for the types of projects under the DOT "covered programs" funded under ARRA.

I understand that if the State of North Carolina is unable to maintain the level of funding identified in this list, the Secretary of Transportation will thereafter prohibit the State of North Carolina from receiving additional limitation pursuant to the redistribution of the limitation on obligations for federal-aid highway and highway safety construction programs that occurs after August 1 for fiscal year 2011.
