Pursuant to the Section 1511 Transparency and Oversight Certification for recovery projects as required by the American Recovery and Reinvestment Act of 2009 (ARRA), enclosed is the State of Oklahoma's certification that the Oklahoma non-urban Transit Recovery Projects and the capital expenditures represented have received the full review and vetting required by law and are an appropriate use of taxpayer dollars. This Certification is provided for the included list of Recovery Projects only and is representative of the non-urban Transit phase of Oklahoma's Statewide program

The projects are proposed to be financed with ARRA funding and may draw from multiple funding sources. The final financing and ARRA participation levels has been determined to the extent possible. We anticipate that the final financing determinations will remain subject to further review and modification until the time of the issuance of purchase orders for the specific vans or buses to be acquired. The State will be submitting additional certifications on behalf of the Oklahoma Department of Transportation as necessary to address the remaining ARRA project phases at a later date.


**CERTIFICATION UNDER SECTION 1511 OF
