Pursuant to Title XV, Subtitle A, section 1511 of the American Recovery and Reinvestment Act (Pub. L. 11-5 (Feb. 17, 2009)) (ARRA), I, Ted Strickland, Governor of the State of Ohio, hereby certify (Certification #10) that the attached infrastructure investments funded with amounts appropriated by ARRA under the following headings have received the full review and vetting required by law and that I accept responsibility that such investments are appropriate uses of taxpayer dollars:

"Highway Infrastructure Investment" (to the Federal Highway Administration)

"Transit Capital Assistance"

"Fixed Guideway Infrastructure Investment"

This certification includes projects within the Akron Area Metropolitan Transportation Study (AMATS, Akron, Ohio), Eastgate Regional Council of Governments (Eastgate, Youngstown, Ohio), Miami Valley Regional Planning Commission (MVRPC, Dayton, Ohio), Mid-Ohio Regional Planning Commission (MORPC, Columbus, Ohio), Northeast Ohio Areawide Coordinating Agency (NOACA, Cleveland, Ohio), Ohio-Kentucky-Indiana Regional Council of Governments (OKI, Cincinnati, Ohio), Stark County Area Transportation Study (SCATS, Canton, Ohio), and Toledo Metropolitan Area Council of Governments (TMACOG, Toledo, Ohio) areas. I understand that my state or local agency may not receive ARRA infrastructure investment funding unless this certification is made and posted.
