Pursuant to the Section 1511 Transparency and Oversight Certification for recovery projects as required by the American Recovery and Reinvestment Act of 2009 (ARRA), enclosed is the State of Oklahoma's certification that the Oklahoma Department of Transportation (ODOT), County Phase Four and Association of Central Oklahoma Governments (ACOG) and Indian Nations Council of Governments (INCOG) Phase Five Recovery Projects and the investments represented have received the full review and vetting required by law and are an appropriate use of taxpayer dollars. This Certification is provided for the attached list of Recovery Projects only and is representative of the first phase of ODOT Americans with Disabilities Act Program, the fourth phase of the County and the fifth phase of ACOG and INCOG's Metropolitan Planning Organization Area program.

These projects have been advertised by the Oklahoma Department of Transportation and are currently scheduled for construction bid letting in 2009 and early 2010. The projects are estimated to be financed with multiple funding sources, including ARRA funding. The final financing and ARRA participation levels will be determined to the extent possible at the time of authorization, and we anticipate that the final financing determinations will remain subject to further review and modification until the time of the award of the resulting contracts. The State will be submitting additional certifications on behalf of the Oklahoma Department of Transportation as necessary to address the remaining ARRA project phases.
