1. GRANTEE: (See individual authorization letter)
2. PURPOSE AND LIMITATION:
 - a. This special permit authorizes the transportation in commerce of cylinders transported by private or contract motor carrier with alternative marking and shipping paper documentation. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
 - b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
 - c. Unless otherwise stated herein, this special permit consists of the special permit authorization letter issued to the grantee together with this document.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR §§ 172.202(a)(5)(i)(B), 172.202(c) and 172.303 in that alternative marking and shipping paper documentation is authorized and § 172.301(c) in that the marking requirement is waived.
5. BASIS: This special permit is based on the application of Worthington Cylinder Corporation dated April 5, 2010 submitted in accordance with § 107.105 and the public proceeding thereon.

6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. SAFETY CONTROL MEASURES:

- a. PACKAGING - Prescribed packagings are as required by the HMR. Only 14 ounce and 16 ounce cylinders may be transported under the terms of this special permit.
- b. OPERATIONAL CONTROLS - Transportation is authorized by private or contract motor carrier only.

8. SPECIAL PROVISIONS:

- a. Each outer packaging required by § 173.301(a)(9) must be marked with the proper shipping names and identification numbers for Methyl acetylene and propadiene mixtures, stabilized and Petroleum gases, liquefied or Liquefied petroleum gas without regard to the package containing both gases.
- b. Each shipping paper may be marked with the proper shipping names and identification numbers for Methyl acetylene and propadiene mixtures, stabilized and Petroleum gases, liquefied or Liquefied petroleum gas without ensuring the transport vehicle contains both gases.
- c. The quantity notations required by § 172.202(a)(5)(i)(B) and 172.202(c) are waived; however, an indication of the total number of cylinders transported under the terms of this special permit must be provided (i.e., the number of cylinders or the number of packages containing cylinders).

- d. The marking requirement in § 172.301(c) is waived.
- e. Each shipper paper must be notated "DOT-SP 15001" as required by § 172.203(a).
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor Vehicle.
- 10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.
- 11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:
 - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
 - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
