1. GRANTEE: StarLite Propane Gas Corporation Bay Shore, NY

2. PURPOSE AND LIMITATION:

- a. This special permit authorizes the transportation in commerce of DOT Specification cylinders containing liquefied petroleum gas (LPG) and/or residue of LPG without hazard warning labels when transported in a transport vehicle that is placarded. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
- b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
- c. No party status will be granted to this special permit.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 172.301(a) in that the proper shipping name and identification number need not be marked on each package, § 172.301(c) in that marking of the special permit number on each package is not required and § 172.401 in that each cylinder must be labeled except as provided herein.
- 5. <u>BASIS</u>: This special permit is based on the application of StarLite Propane Gas Corporation dated February 13, 2012, submitted in accordance with § 107.109.

6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. SAFETY CONTROL MEASURES:

a. <u>PACKAGING</u> - Prescribed packagings are DOT specification cylinders authorized for the transportation of propane.

b. OPERATIONAL CONTROLS:

- (1) The cylinders must be transported in either an open motor vehicle or a closed motor vehicle that fitted with venting to prevent the accumulation of flammable gas.
- (2) Each motor vehicle must be placarded on each end and each side with the FLAMMABLE GAS placards.
- (3) The identification number "1075" must be marked on each motor vehicle as required by § 172.332.
- (4) Shipping papers must reflect a correct current accounting of all cylinders both full and expended.
- (5) Cylinders must be secured in the vehicle in accordance with § 177.834(a).
- (6) Transportation is authorized by private motor carrier, one-time, one-way directly to StarLite Propane Gas Corporation to be refurbished or evacuated and scraped only.

- 8. <u>SPECIAL PROVISIONS</u>: A current copy of this special permit must be maintained at each facility where the package is offered for transportation.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.
- 10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et seq</u>:
 - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
 - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
